Re. Response to Notice of Complaint No. 2024-09-RG

Dear Auditor Staff:

This will respond to Mr. Wooley's wrongheaded complaint that I contributed a total of \$700 to "Rene for Portland" in the current election cycle, allegedly exceeding the allowable contribution limit. There was no violation here.

Unsurprisingly, my wife (Courtney) and I share a joint checking account.


On March 4, 2024, Courtney wrote a check to "Rene for Portland" in the amount of \$350.00. A copy of that canceled check, which was apparently received by the campaign on March 5, is included here. It is signed by Courtney and the memo section of the check makes clear that she was the contributor.

On April 7, 2024, I made an online donation to "Rene for Portland" in my own name in the amount of \$350.00. A record of that contribution—my only contribution to the campaign this cycle—is also included here.

Two contributions from two separate people, each within the contribution limits = no campaign finance violation.

I trust this resolves any concerns and I request that the Portland City Auditor provide me with documentation that this complaint has been resolved as unsubstantiated.

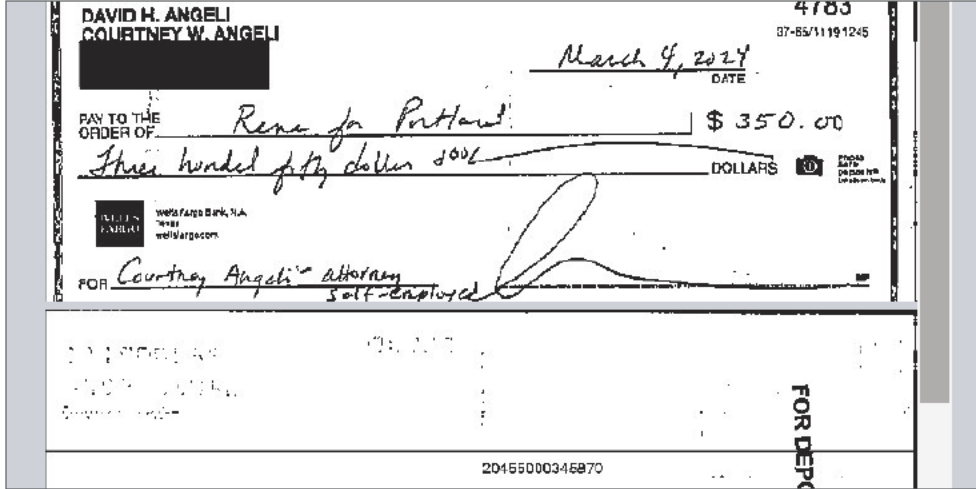
