Final Plat Application Submittal Requirements

All Final Plats must be submitted via email at LandUseIntake@portlandoregon.gov or by mail to 1900 SW Fourth Avenue, Portland OR 97201. Failure to submit the items listed below will slow down the review of your application. In some cases, the City cannot begin reviewing your application until the required information is provided.

All Final Plat submittals must include the following:

1. **Signed application form.**
2. **Final Plat fee** – For current fees, please consult the BDS Web site for Land Use Review Fees at www.portland.gov/bds/current-fee-schedules. A Land Use Services Technician will contact you regarding payment of fees once the application is received.
3. **Final Plat survey**
4. **Title report** - A current title report verifying ownership and detailing any deed restrictions.

All surveys and plans must be in electronic (.pdf) format and drawn to scale.

Additional items that may be required:

5. **Standard Land Division Supplemental plan** (if required by a condition of approval of the preliminary decision)
The plan must use the Final Plat survey as a base map and show how relevant development standards, conditions of approval and utility service requirements are met. At minimum, the surveyed location of all existing development (including structures and paved areas) on the site at the time of the final plat application must be shown on the supplemental plan.
6. **Middle Housing Land Division (MHL) As-Built Survey** - An as-built survey showing building footprints and any building projections within distances to proposed lot lines, and the location of underground services in relation to any tracts and easements, is required for all MHL final plats.
7. **Maintenance agreements** - Maintenance agreements for any private easements or tracts.
8. **Other** - Any other information necessary to satisfy conditions of approval of the preliminary decision.

You are encouraged to submit your Final Plat for concurrent review with the Multnomah County Surveyor (www.multco.us/surveyor, 503-988-3600). Please contact your surveyor about this requirement.
