- Increase health protections for all occupants near residential demolition activity;
- Ensure regulations are clear and enforceable.

2018

July 1<sup>st</sup> New Demolition Code & Admin Rule took effect

2019

Sept 9<sup>th</sup> BDS Staff presented the 1<sup>st</sup> Year Program Report at OHA's Lead-based paint Stakeholder meeting

### Summary – Code Chapter 24.55

- ✓ Only 2 sections of this Chapter of City Code amended
  - 24.55.150 Definitions
  - 24.55.205 Site Control Measures
- ✓ Many subsections were moved to the Administrative Rule, then amended and updated.
- ✓ Corrected language and updated references

- ✓ A review of current site control requirements including site setup, exterior component removal, and debris containment
- ✓ Improving the 3 Inspections – purpose, requirements and timing of inspections, as well as an alternative method

### Required Inspections - amended

- ✓ 1. Pre-demo work – Initial inspection
- ✓ 2. During demo work inspection
- ✓ 3. **NEW** 2<sup>nd</sup> During demo work inspection with approval to begin as inspector observes Mechanical demolition
- ✓ 4. Post demo - Final inspection

- ✓ Enforcement Process

## Chapter 24.55 Residential Demolitions & Admin Rule Amendments Summary

### Enforcement & Fines – Previous Version

1st violation = Correction notice

2<sup>nd</sup> violation = 1st Citation + \$ 5,000 fine  
*(Even with multiple violations on single inspection)*

3<sup>rd</sup> violation = 2nd Citation + \$10,000 fine

4<sup>th</sup> violation = 3rd Citation + \$15,000 fine

All additional Violations = + \$15,000 fine

## Chapter 24.55 Residential Demolitions & Admin Rule Amendments Summary

### Enforcement and Fines - Proposed

#### Violations that CANNOT be corrected

1st Violation	= \$10,000 fine
2nd Violation	= \$15,000 fine
3rd Violation	= \$20,000 fine
4th Violation	= \$25,000 fine
All Subsequent Violations	= \$25,000 fine

**NEW**

#### Violations that CAN be corrected

1st Violation	= Correction Notice only
2nd Violation	= \$5,000 fine
3rd Violation	= \$5,000 fine
4th Violation	= \$5,000 fine
All Subsequent Violations	= \$5,000 fine

### Admin Rule has a New Format

- ✓ Restructured layout & moved sections for better ease of use for public and staff
- ✓ Corrected language and updated references
- ✓ Appendices specific for Asbestos and Lead-based paint
