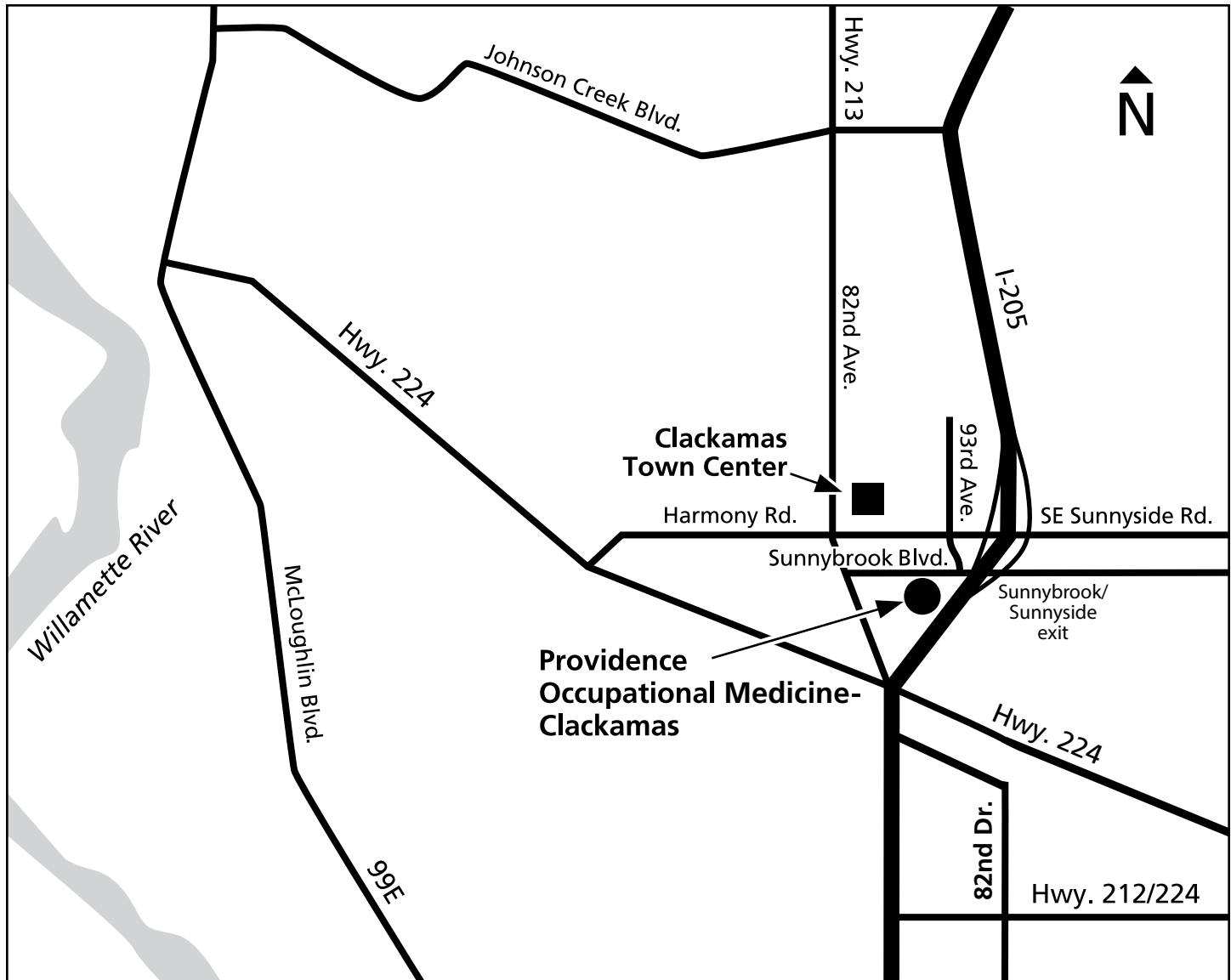

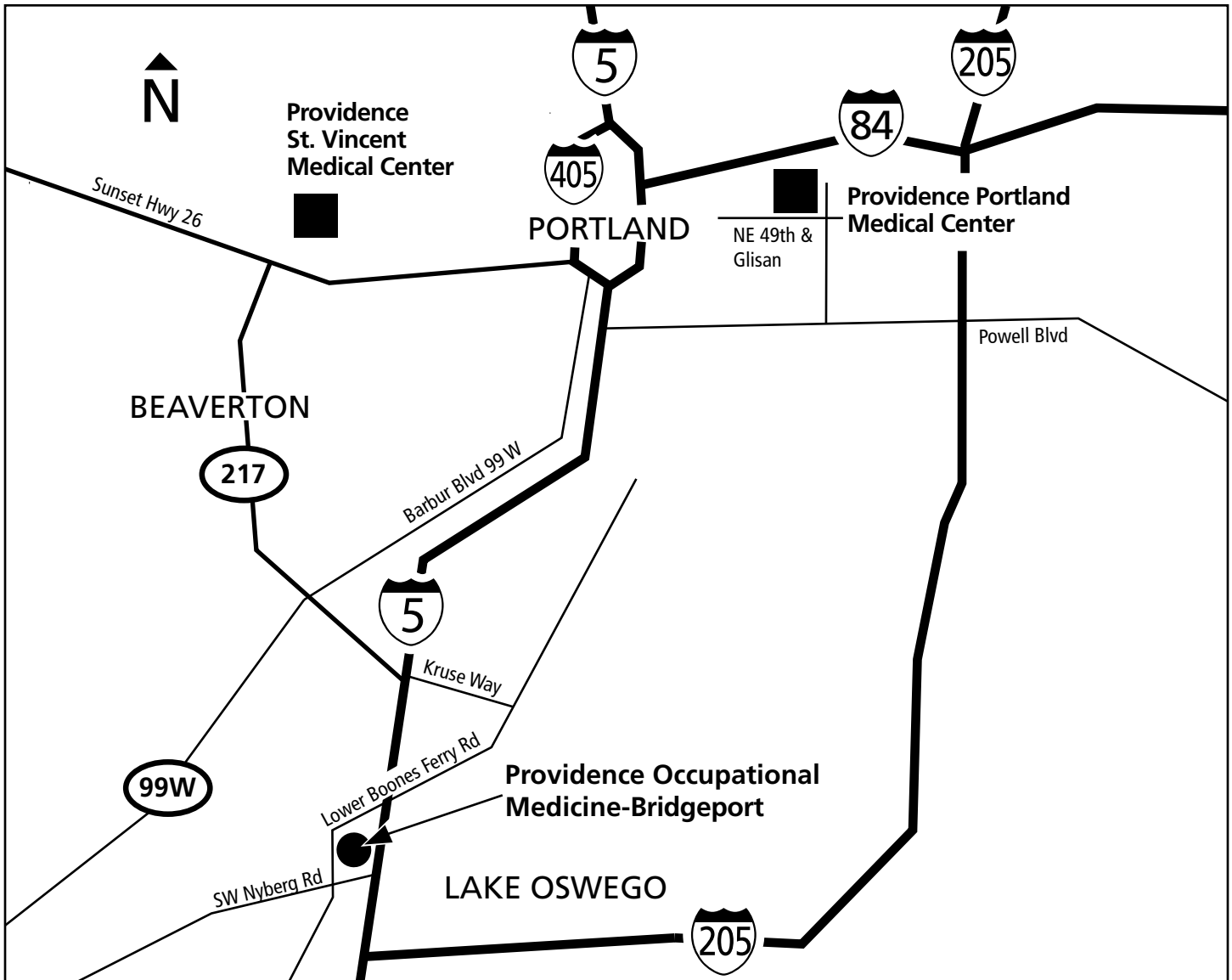

DIRECTIONS FROM I-5 SOUTH

Heading south from downtown Portland, take Exit 290 for Lower Boones Ferry Road toward Durham. Use the second from the right lane to turn right onto Lower Boones Ferry Road. Use the left two lanes to turn left onto Lower Boones Ferry Road/Tualatin 1. Continue to follow Lower Boones Ferry Road. The clinic will be on the left.

DIRECTIONS FROM I-5 NORTH

Heading north from Tualatin, take Exit 290 for Lower Boones Ferry Road. Use the second from the left lane to turn sharply left onto Lower Boones Ferry Road. Use the left two lanes to turn left onto Lower Boones Ferry Road/Tualatin 1. Continue to follow Lower Boones Ferry Road. The clinic will be on the left.

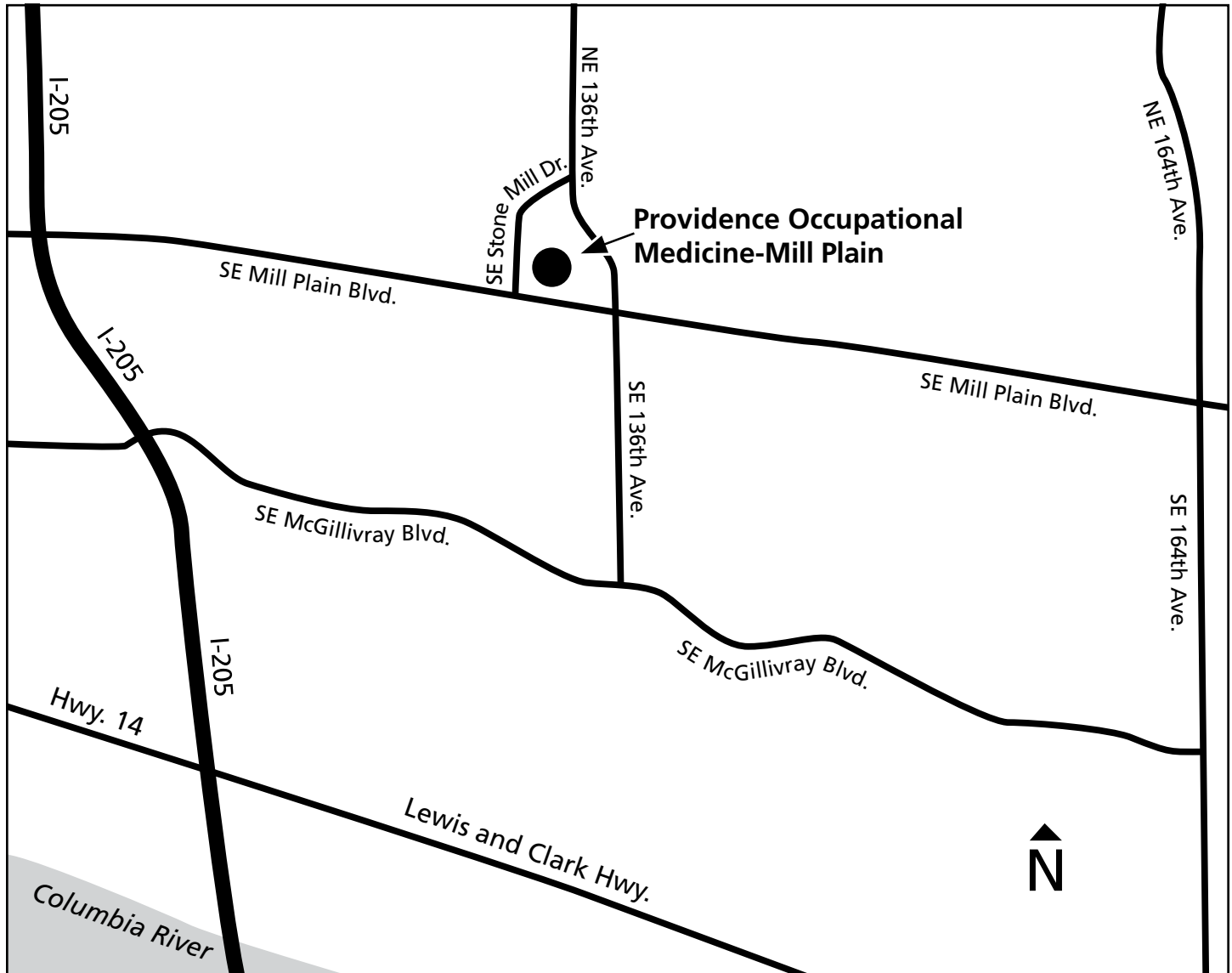

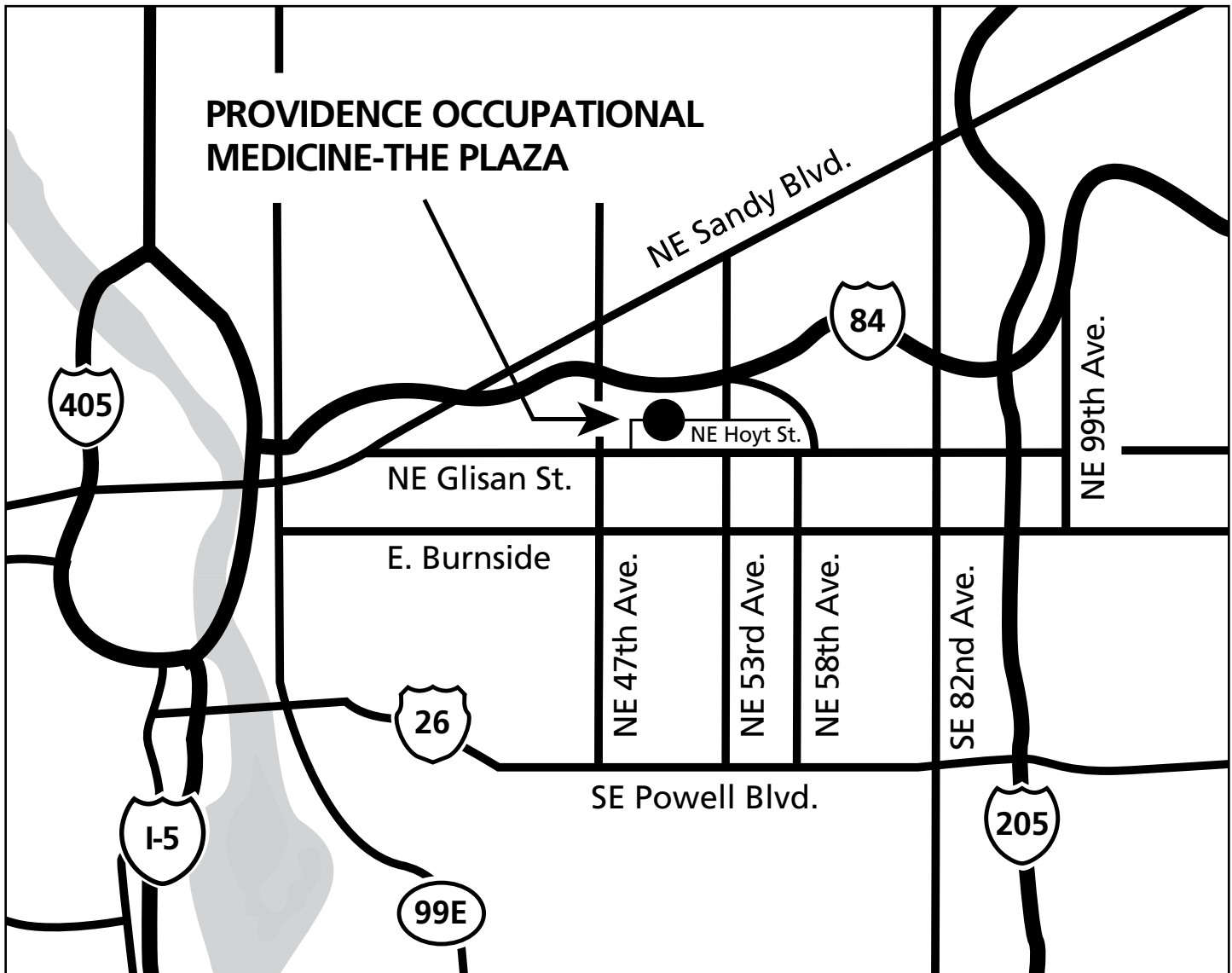
