



INTRODUCTION

General

This is the third of four Columbia Corridor Industrial/Environmental Mapping Project documents. It is a support document for the *Industrial Mapping and Annexation Rezoning for the Columbia Corridor* and the *Inventory and Analysis of Wetlands, Water Bodies, and Wildlife Habitat Areas for the Columbia Corridor*, and presents the proposed mapping of the environmental concern zone and new industrial zoning designations for the Columbia Corridor. Proposed changes are noted on section and quarter section zoning maps which show existing zoning. Zone designations proposed for elimination are crossed out, while new designations are hand-lettered, for ease of identification.

Changes are generally proposed only for industrial zoning, annexation rezoning, or for environmental protection of significant natural resource areas. There are areas of commercial and residential development for which no changes are proposed.

Industrial Zone Designations

The new industrial zones were developed in 1985 to foster economic development by providing more flexibility and certainty to new, relocating, and expanding industrial firms. At the same time, residential and commercial areas are protected by ensuring that nearby industry is compatible.

Three new industrial zones were created to accomplish this: Heavy Industrial (HI), General Industrial (GI), and General Employment (GE). The HI and GI zones are comparable to the old M1 and M2 zones. The GE zone permits industrial and commercial activities, but generally not new housing.

The GI and GE zones each contain two sets of site development regulations, so as to work well if applied in either older developed areas, or in new less developed areas. The applicable site development regulation appears on the proposed zoning maps with a numeral 1 or 2 following the base zone. For example, GI-1 was tailored to older developed areas such as the Albina and Central Eastside districts. GI-2 was tailored to new less developed areas such as Columbia South Shore and Mock's Landing.

Buffer regulations are included in the new industrial zoning regulations where industrial and residential activities abut one another and where natural or manmade features do not provide adequate separation.

Environmental Concern Zone Designations

The Environmental Concern zone (E zone) is an overlay zone that is being applied in conjunction with existing base zones. It protects important natural resources, including fish and wildlife areas, ecologically and scientifically significant natural areas, water areas, and wetlands. It has been developed as a part of the City's Comprehensive Plan periodic review and to comply with Oregon Statewide Land Use Planning Goal 5.

The E zone is applied to areas adjacent to natural resources as well as to the resources themselves. The intent is to buffer and protect the resource, and to provide both a visual and functional transition between the resource and the maximum development allowed by the base zone.

There are two designations within the E zone: Environmental Conservation (ec), and Environmental Natural (en). The ec designation is designed to be placed on those resource areas where important values have been identified. Development is permitted if done in a manner which protects remaining resources and mitigates for lost resource values. Most natural resource areas are included in this category. The en designation is for selected areas of very high value where development is limited.

The level of review for proposed development in an area receiving the environmental protection zone will depend upon the distance from an identified natural resource. For land in the outer 25 feet of an E zone (the "transition area"), the emphasis of the site development regulations and approval criteria is to ensure that development will not harm the adjacent resource. Review in this area is processed through a Type II procedure. If a proposed development is within a resource area, a Type II or III procedure (depending on whether the resource area is designated en or ec), is required. Approval criteria are designed to discourage unnecessary intrusion into a resource area and to insure preservation of resource values through mitigation.

A Management Plan approach to resource protection is a part of the E zone as an alternative to the normal review procedures. This approach recognizes that, collectively, individual resource areas sometimes form a system that has values in excess of the sum of values of the individual sites. A Management Plan addresses resource conservation on an area-wide level, and provides greater certainty to potential developers since development in conformance with an approved management plan may occur without further environmental review.

How to Use This Document

Maps in this document are half-size reproductions of the Multnomah County Assessors Maps. Most are of quarter section size, 0.5 miles on a side. Scale is 1 inch = 400 feet. In some areas, only full section maps are available. They cover four quarter sections. These maps are indicated by cross-hatched areas on the Map Key following the Introduction. The scale of full section maps is 1 inch = 800 feet.

To find the desired map number, locate the property on the Map Key and note the grid square. Find the quarter section map number by taking the number from the left-hand column and adding the number from the top row that line up with the grid square.

Example: 2300+35 is map 2325

Section maps are identified by the map number of the quarter section in the upper left-hand corner.

Maps in this document are arranged in ascending numerical order.


