#### **Revenue Discussion**

All current revenue is in-line with budget assumptions based on the number of subscribers and right-of-way fees.

#### Revenue Risks

The Office is largely General Fund and risks will track Citywide risks associated with that funding stream. Intergovernmental revenues associated with the MHCRC program have no noteworthy risks in the current fiscal year, although analysis of the cable franchise fee activity that these revenues are derived from is expected to decline in future fiscal years. Specific impacts are indeterminate at this time.

#### **Expenditure Discussion**

Due to changes in prioritization, the bureau shifted their focus and the priorities of staff towards ARPA related programs causing an underrun in the original expenditures and need for General Fund program carryover requests.

With the move, OCT lost the administrative support services provided by OMF. A director and a financial analyst position were initially recommended to support the bureau. Only a director-level position (Manager II) was funded at the time of the move. OCT has a temporary, two-year position and requests the funding to convert the 1.0 FTE position from a temporary position to a regular position. A financial analyst is needed to serve as the bureau's finance, administrative and budget manager, directing the bureau's annual budget development and monitoring processes and other financial roles for the bureau. This position is the bureau's only financial analyst.  The position is funded jointly through the General Fund and through the MHCRC Special Appropriation and Compliance Funds. F Conrad Hurdle LLC This request is for \$6,600 encumbered and unspent from the contract executed in June of 2019 for \$17,150. The project plan for this work was designed to support an inclusive vetting process with a broad array of community stakeholders that include Digital Inclusion Network members and leaders from community-based organizations, local governments, businesses, schools, libraries, etc. that work directly with BIPOC residents. The contract is extended to December 31, 2021 to complete the project and make adjustments due changes adopted to ensure safety in response to COVID-19.  CBG Communications Comcast Franchise Renewal This request is for \$37,582 encumbered and unspent from the contract executed in February of 2021 for \$55,020. The negotiations for a cable franchise agreement with Comcast are set to continue through early 2022. The MHCRC has included funds in the FY 21-22 budget but need the additional encumbered funds to complete the negotiations.  Speer Hoyt/LGLG This request is for \$132,883 encumbered and unspent from the contract executed in October of 2018 for \$150,000. Negotiations with cable companies this fiscal year and possible updates to the MHCRC Intergovernmental agreement will require higher than anticipated legal services.
