Noise Review Board April 13, 2016 Minutes - Draft

Present: Carol Gossett, Melissa Stewart, Julie Greb, Kerrie Standlee, and Paul van Orden

Minutes: Kathy Couch

Call to Order – 6:07 pm

Proposed Variance Fee Schedule Increase – Paul van Orden

Paul explains that Commissioner Fritz's goal for the upcoming year is to get the Noise Office to be self-sustaining by 75%

Currently the office is funded with 64% coming from the General Fund.

Paul shares a Power Point presentation on the proposed fee structure, which is included in the minutes.

Concerns and questions raised by the Noise Review Board

<u>Melissa Stewart</u> - how do the Portland's fees compare with similar cities that have these kinds of permits? <u>Carol Gossett</u> – Do other bureaus of the city have arrangements like this? How do we compare? She says typically, in a budget that includes fees, the charges amount represents service and the time that it takes. How do we justify the large increase in numbers?

<u>Julie Greb</u> – She is in favor of anything that funds the Noise Office. Since the office is grossly understaffed and it doesn't serve the public, and can't enforce anything, the city doesn't seem to prioritize the Noise Office in the last handful of fiscal cycles.

<u>Kerrie Standlee</u> – He would like to hear more about the basis of the rates he is looking at. He feels that the different rates are all over the place, in terms of subcategories. Some things appear to be hit harder than other categories with more impact. He says that there should be more thought put into figuring out where it is time and who should be paying for it. He would like to understand more the different timeline categories. He does not understand the meaning of some of the items, particularly variances that have a board review. He does not understand the 3 month project for \$1500. Julies clarifies that it would be \$5000. \$3500 for the board hearing and \$1500 for every 3 months. Paul then says that there is a line missing on what they are looking at.

Fee structure is:

\$3500 for the board hearing

1st 3 months to work in the City is \$5000

\$1500 is for additional 3 month increments.

When you add the first 2 pieces together, the amount for the first 3 months would be \$8500

Melissa Stewart – in terms of other events, are 3 days the same price as 1 day?

Paul says that if all we do is increase variance fees, without increasing citations, we run the risk of large companies taking the fines instead of paying for the variance fees.

office of neighborhood involvement

<u>Carol Gossett</u> – This structure is predicated on a good economy. What happens if we go into a recession again, and no one is building, and this all drops? Would that mean staff layoffs? Her other concern is that some financing, such as low income and mod housing is very tightly budgeted and financed and these costs could make a difference. She feels that a range of pricing rather than the same fee for everyone may be something to look at. She would hate to think that these fees would keep a project like that from moving forward.

<u>Kerrie Standlee</u> –Would there be consideration given to construction with no impact? Different rate schedules for different time periods? Is that a possibility?

Public Testimony

<u>Brooks Hickerson</u> – He doesn't see a fee scheduled for those who don't apply for a variance and then violate the code. Do they get a variance after the fact? It's explained to him that this would reference the conversation earlier regarding citations.

ODOT - Carole Newvine

She is looking at the fee schedule and comparing it to the variance they are asking for tonight, and the costs look to be minimally \$14,500, if you are going to go by month. This is excessive. ODOT takes care of their own complaints, and, with the large amount of outreach they do, she doesn't believe that the Noise Office receives complaints on any of the ODOT projects. Public entities should be grandfathered in, or have a different fee schedule. Developers can pass it on to tenants. We pass it on to the taxpayer. She would like to see a lot of outreach, and ODOT needs time to respond to this proposal.

Mary Sipe

She supports the proposal. She distributed a packet of her suggestions for the fee proposal. They are attached to the minutes.

Sally Mize

She asks about rules for boats amphibious planes. Paul explains various entities have jurisdiction, dependant on where they are. (It may be Noise Office, although we would need to interface with the Sheriff, as we don't have a boat, and if they are in the air, then FAA has jurisdiction)

Request from Pioneer Courthouse Square on renewal of 5-year variance Shannon Weisinger- Production Director and Lindsay Klute, Event Director

A 5-year variance (2016-2021) is requested in order to present events at Pioneer Courthouse Square during the lunch hour as well as on weekends. Similar events occur each year. Requested hours for the variance are from 11:30 a.m. to 1:30 p.m. and after 5:00 p.m. to 10:00 p.m. Monday through Friday. Unspecified hours are requested for Saturday and Sunday from 8:00 am to 10:00 pm. The applicant has requested the same decibel levels as their previous variance, namely, 75-80 dBA, as measured at any unaffiliated neighboring commercial property.

Staff at Pioneer Square, in conjunction with direction from the Noise Control Officer Paul van Orden, had contacted a mailing service organization, AD Mail Inc to obtain addresses for 3,000 letters distributed to residences and businesses surrounding Pioneer Courthouse Square, to inform them, as well as offering detail on the computerized hotline number, and the direct line of the Production Director for Pioneer Courthouse Square. The same mailing area was utilized to do notification for this variance application as the last multivear noise variance.

Background documents on Pioneer Courthouse Square are attached to the minutes.

Kerrie Standlee asks if the annual reports that were part of the conditions in the last were variance given regularly. He would like a condition included addressing measurements taken at residences in Park Tower West, since there are now new residents since the last variance.

He would also like a condition added onto the voicemail to request the complainant leave their number, so they can be contacted. How many complaints related to square? Want conditions to reduce complaints.

Motion was made by Melissa Stewart to grant a variance for Pioneer Courthouse Square for the period of May 1, 2016 through April 30, 2021 with the conditions below (Kerrie Standlee's suggestions included in the conditions). Julie Greb seconded the motion. The motion passed unanimously, 4 - 0

- The variance will run from May 1, 2016 through Midnight April 30, 2021.
- The variance shall include the following varianced times. On weekdays, the permitted hours are 11:30 a.m. to 1:30 p.m., and from 5:00 p.m. to 10:00 p.m. On weekends and holidays the permitted hours are all day from 8 a.m. up to 10 p.m.
- The general standard for the variance shall be as follows: The permitted sound levels shall be 75 dBA (Max) with occasional peaks up and not exceeding 80 dBA, as measured at any unaffiliated neighboring commercial property.
- The more specific standard directly as measured at the homes or dwelling places of surrounding neighbors shall be as follows: The permitted sound levels shall be 70 dBA (Max) with occasional peaks up and not exceeding 75 dBA, as measured at any height on an apartment building or residential occupied building.
- Pioneer Courthouse Square, in conjunction with the Noise Control Officer, will contact Park Avenue West to set up a noise meter for readings during an event.
- The square will work out an acceptable measurement procedure with the Noise Control Officer to ensure compliance with the variance. The procedure will be made readily available to any staff working to monitor events for Pioneer Courthouse Square.
- The applicant will forward any complaints they receive to the Noise Control Office to be forwarded to the Noise Review Board.
- The applicant shall continue their complaint hotline to operate during events, especially during evenings and weekends, and a message shall be added requesting complainants leave their phone number, so their complaint will be better addressed and resolved. The phone number for concerns will be distributed to neighbors and Neighborhood Associations with all notification of events. This will include all residential receivers within a three block radius of Pioneer Square.
- Pioneer Square staff will notify the Noise Control Officer of any anticipated louder events that will be occurring at the Square.
- Representatives of Pioneer Square will return to the Noise Review Board by April 30, 2017 to report on progress to date and any complaints.
- An annual report of the events and sound levels measured will be supplied to the Noise Control Officer. It should include any information related to complaints.
- Pioneer Courthouse Square will provide a notice to all event promoters renting the facilities which they
 will sign that states they acknowledge that they will comply with the Noise Variance conditions, or they
 may face citations or other enforcement action from the Noise Control Officer or Officers from the
 Portland Police Bureau.

- This variance is not intended to cover any major festivals, concerts, or other activities whose sound
 impacts are clearly unusual or extensive as determined by the Noise Control Officer. Such events will be
 required to acquire a separate and additional variance in which the Square has co-applicant status with
 promoters or sponsors of the event. The variance shall be issued by the Noise Control Officer with
 conditions he or she determines are appropriate to the variance.
- The variance is subject to review, including revocation, based on the receipt of any complaint(s).

Oregon Department of Transportation variance request for OR99E: SE Harold Street to SE Harrison Street – bridge replacement and pavement preservation project

Marjorie West, Susan Hanson, Dillon Tannler, Bruce Bercot

This request will repave 2.6 miles of OR99E from SE Harold to SE Harrison (part of the project is located in NE Milwaukie). The pavement, last replaced in 1994, has deteriorated and is need of repair. Grinding and repaving of the highway will repair and preserve the roadway and provide a smoother roadway surface. The current striping, last replaced in 1994, has deteriorated and is need of repair. Grinding and repaving of the highway will repair and preserve the roadway and provide a smoother roadway surface. The current striping will be replaced with durable, profiled thermoplastic striping and reflective pavement markings. Additional project elements include: replacement of Crystal Creek Springs Bridge with a culvert, drainage improvements on OR99E from SE Harold to Tolman Street, and sidewalk ramp upgrades on OR99E.

The variance request is for 72 nights of work. Originally requested estimated timeline was April 1, 2017 – September 31, 2017. They would like to modify this timeline to 72 nights with intermittent periods of nighttime work between January 3, 2017 and November 17, 2017.

The closest residential receptors are approximately 50 feet away from the roadway repaving work. An assisted living facility, Westmoreland Union Manor, is located approximately 170 feet away from where the loudest activities will be taking place (replacing Crystal Creek Springs Bridge). Existing dBA levels were monitored to establish a baseline, and, accordingly, the project is anticipated to be 12- 22 dBA higher than the existing levels. This is a moving operation, and ODOT is estimating nighttime work will consist of 59 nights for paving, 12 nights for the bridge replacement, 15 nights to bring to ADA standards, 10 nights for drainage improvements. The highest concentration of the request for 72 nights of nighttime work will be 20 nights adjacent of 72 nights. Bridge work drainage and reconstruction will happen concurrently during weekend closures. Paving and striping are anticipated to last for 20 nights. ODOT will attempt to perform the loudest work, jack hammers, saw cutting and generators before 10 pm and pile drivers during the daytime hours.

They will have a 24 hour noise hotline with an answered line.

Outreach

ODOT performed 18 months of outreach to stakeholders, which included a website for over a year. Moving forward, the website information will include all construction and traffic information. They sent out a fact sheet, held meetings, sent mailings and emails, which included 2 Neighborhood Association groups and Business Association groups. They sent out a mailer in March to 11000 people within ¼ mile of the project highlighting noise notification, including this hearing information. They held an Open House on April 7, and had a station specific to noise there. They also held an online Open House that consisted of short videos of project staff explaining more about the project and included contact information. They have been engaging in direct communication West Union Manor and working closely with them. Closer to construction dates, they will do outreach next spring. On all communications, they prominently display hotline information.

Melissa Stewart asks for clarifications in the amount of nighttime work. She is told that the requested 72 nights would be intermittent during the project between January and November.

Patrick Romero, consulting engineer for ODOT describes how they predict construction noise levels. They look at the defined baseline daytime and nighttime noise levels and plug the anticipated levels in, using typical levels on construction areas he's worked on in past.

Much of their mitigation is complaint generated. Inspectors also have a dBA monitor with them while on the project, and the contractor has them onsite too. ODOT Inspectors are on the project all the time.

Kerrie Standlee asks for a copy of the variance application

Mary Sipe asks about the pile driving component of the project. She is told that they are using vibratory pile, which is around 90 dBA. It consists of driving 4 sheets, which lasts around 2 hours. This is commonly used shoring piles, as opposed to deep foundations.

Kerrie Standlee asks for some detail on one of the mitigation measures. Bullet 2 in their request (Use equipment with sound control measures no less effective than those provided on the original equipment) He would like this to say that the equipment in the above paragraph to be more effective than the original muffler, instead of "no less effective"

Julie Greb makes a motion to approve a variance for Oregon Department of Transportation for 72 nights of construction work between January 3, 2017 and November 17, 2017

With the conditions listed below.

Kerrie Standlee makes an amendment that pumps, portable generators, air compressors will be required to have sound enclosed control devices of higher quality than original equipment Melissa Stewart seconds the motion.

Motion passes unanimously 4 - 0

Nighttime construction activities will comply with ORS 467, OAR 340-035, all other applicable laws and regulations, and to the extent feasible, the following construction noise abatement measures:

- No construction will be performed within 50 feet of an occupied dwelling on Sundays, legal holidays, or between the hours of 10:00 p.m. and 6:00a.m. on other days.
- Sound levels at any residential structure may not exceed a 75dBA Leq as measured for 15 minutes, with a Fast meter response.
- Equipment will use sound control devices higher quality than those provided on the original equipment. Equipment with un-muffled exhausts is prohibited.
- Equipment will comply with pertinent equipment noise standards of the EPA.
- Saw cutting, grinding, pile driving and jackhammer activity to occur before 10:00 pm and 6:00 am or during the weekend closures

There will be a 24-hour telephone response line (Hot Line) available. The Project Manager shall investigate complaints and develop information necessary to address complaints within 24 hours or before the next scheduled night work. Noise Control Officer must be notified of any complaints within 7 days of the complaint, including a report describing how the complaint was resolved

If a specific noise impact complaint is received, one or more of the following noise mitigation measures may be employed:

- Stationary construction equipment will be located as far from nearby noise sensitive properties as feasible.
- Construction operations will be rescheduled to avoid periods of noise annoyance identified in the complaint.
- Idling equipment will be shut off
- Nearby residents will be notified whenever extremely noisy work will be occurring.
- Temporary or portable acoustic barriers will be installed around stationary construction noise sources.
- Electric-powered equipment will be operated using line voltage power or solar power.

<u>Sally Mize</u> – reads statement from Stan Penkin (attached to minutes)

<u>Patrice Hanson</u> – Says that Brooks Hickerson left a letter and hopes the board reads it. She adds that she feels that the board's not supporting Commissioner Fritz's pile driving idea is baffling and disturbing and inconsistent with the mission of the board. Both she and Mary Sipe received an award from the NW Examiner (local NW neighborhood newspaper) from the work they did to stop developers from using "impact hammer" pile driving methods. She thought they would come to the city and get support. She feels that the NRB succumbed to pressures from the construction industry, specifically DeWitt Construction, rather than acting for the good of the

community. She feels that anyone who thinks pile driving is only a nuisance should be required to live across the street from a project for a day or two. She addressed the composition of the board, wondering why there is a rep from the construction industry on the board, instead of garbage, or music venues. She thinks there should be a temporary seat for someone who is being affected by noise so they can be present at meetings when the public isn't invited. She would like to see a model of foot patrols and Neighborhood Watch for noise.

Mary Sipe - Reads statement (attached to minutes).

She also distributes the construction noise restrictions from the town of Aspen Colorado (ski resort with population of approximately 6,000 people in the Rocky Mountain region) (the document is attached to the minutes)

Board explains their rationale for their non-support of the pile driving proposal to all those who came to express their opinion. (no change in outcome, unenforceable given staffing and time issues, felt it needed much more work before being something they could approve)



BACKGROUND:

Title 18 establishes sound levels based on the zones of both the source and receivers of noise. Events that produce noise above permitted levels may be considered for variance from the code. The Noise Review Board is charged by code to review and act upon some of these applications. The review must consider the physical characteristics; times & duration of the emitted sound; the geography, zone and population density of the affected area; whether the public health, safety or welfare is impacted; whether the sound source predates the receiver(s); and whether compliance with the standard would produce hardship without equal or greater benefit to the public. The code does not preclude review of other factors, nor does it specify the weight to be given to each criterion.

REQUEST:

Ivan Ratcliff, representing Oregon Zoo, is requesting a noise variance for the Oregon Zoo Summer Concert series for summer, 2016 - 2018. The Oregon Zoo is requesting a noise variance for the Oregon Zoo Summer Concert series for up to 19 concerts from mid-June to mid-September, with sound levels not to exceed 65 dBA at residences, between the hours of 3:00 p.m. until 10:00 p.m.

FINDINGS:

- A. The public's health, welfare and safety are not affected by the anticipated noise levels, except possible temporary interference with sleep at later hours and for closer-in properties.
- B. The sound source does not predate receivers.

Park Events

• Charge "per day" fees

Currently there is no difference is fees paid for events lasting 1 day vs. up to 4 days.

Charge a fee for each event.

Currently variances are issued charging a single fee for multiple events, such as weekly Farmer's Markets, Summer Concerts, movies etc.

The Portland Parks & Recreation Summer Free For All events have large corporate sponsors and a single variance with a single fee is issued for all events over the course of the summer. A Single Noise Variance Permit was issued in 2015 for 152 events with a single \$83.00 low impact fee charged. The 2014 SFFA & 2015 SFFA Final Reports show

If a Wedding Planner happens to have 10 weddings over the course of the summer, a single variance would not be issued for all 10 events taking place at different dates in different locations. A separate variance would be required for each wedding with a fee charged for each event. This does not seem equitable.

Construction

- Discontinue the practice of issuing a single Noise Variance Permit for multiple construction activities such as crane erection, crane dismantling, and early morning concrete pours.
 - Separate variances will allow for better oversight.
 - o Three different activities should generate three separate fees.

It appears that the current practice for construction companies is to submit a single Noise Variance for multiple activities spanning a 12 month period. The maximum fee is \$850.

The nature of crane erection and dismantle vs. concrete pours is very different. Crane erection and Crane dismantle usually take place on weekends due to the need to close streets and usually takes no more than a couple of days to complete.

Concrete Pours

• Consider a Construction "sub-category" for early morning concrete pours.

Concrete pours vary based on the height of the building and can span many months.

Noise Variance Applications for early morning concrete pours request start times of 3 am, 4 am, 5 am and 6 am. The main reason for starting concrete pours before 7 am is disruption of traffic. They want to get the concrete trucks in and out before rush hour traffic begins.

Currently a single variance can be issued for up to a 12-month period to include as many as 48+ pours.

Consider issuing Concrete Pour permits for one-month periods or for a maximum number of pours such as 5-10. This would allow better over-sight. If conditions of the Noise Variance Permit are violated (such as more trucks on site than the permit allows) the Noise Control Office has the opportunity to modify conditions.

- C. The zoo has been holding concerts at their location for 35 or more years. In the last twenty years the current Noise Control Officer has had a limited number of complaints filled with Noise Office relative to the number of concerts that occur each summer. On average, the Noise Control Officer reports that 3 concerts a year have a tendency, based on the booking pattern of the selected musical genres, to be of a higher concern for potential community noise impacts. It has been noted by the Noise Officer that many of the other less bass intensive concerts annually are clearly audible at residences but actually fully comply with the 55 dBA City Code standard that is the predominate permitted decibel levl in the neighborhood, up to 10 PM each day.
- D. The last criterion in reviewing Noise Variances speaks to a sort of "balancing test", in which compliance/non-compliance is measured against the "public good." Will the denying of this application produce hardship without equal or greater benefit to the public? Although "benefit" usually refers to economic gain, the Board also includes the pleasure obtained from the viewing of an event, the fostering of interest in an activity, or the pride in one's city, which occurs via national exposure. In the present case the event is not only a well recognized community event, per se, but it also contributes to the national exposure of the City of Portland. The Noise Review Board finds that denying this event will not benefit the public good.

DECISION:

Motion was made by Julie Greb to grant a variance for Ivan Ratcliff, representing the Oregon Zoo, for a 3 year noise variance for the Summer Zoo Concert series to take place between mid-June – mid-September 2016-2018 between the hours of 3:00 pm & 10:00 pm (6:30 pm -10:00 pm actual concert) with the conditions below. Melissa Stewart seconded the motion. The motion passed 4-1 with Kerrie Standlee voting "no".

The Variance is approved with the following conditions:

- 1) The variance shall run for three summer concert season at the Metro Oregon Zoo in the summers of 2016, 2017, and 2018. The permitted hours of operation shall be 3 pm to 10 pm. Sound checks may begin at 3:00 pm and the concerts will be between the hours of 6:30 pm and 10 pm under the permit.
- 2) The Zoo shall be permitted no more than 19 summer concerts each of the three summer seasons that exceed Title 18 Land Use Zone standards under this decision.
- 3) The permitted sound level will be 65 dBA and 80 dBC (Lmax Fast), as measured at any residential property line.
- 4) The Oregon Zoo will work with the Noise Control Officer to designate several monitoring sites that will be monitored at each event.
- 5) The final schedule of concerts will be mailed to the neighbors, using the applicant's current notification addresses.

- 6) A hotline phone line to call in with concerns will be established and with be included in the concert schedule notification announcement to the neighbors. The phone line will be answered by a live person during events.
- 7) Sound levels will be monitored in response to complaints received at the source of the complaints where possible.
- 8) The Oregon Zoo will maintain a log of complaints received and the actions taken to mitigate the community concerns. The log will include the sound level measurement taken in response to complaints. The complete log will be forwarded to the Noise Control Officer within one week after each show.
- 9) The results of the routine noise monitoring for each show will also be forwarded to the Noise Control Officer within one week after each show.

The applicant understands that this variance is subject to review upon complaint.

This decision becomes effective on December 9, 2015.

APPEAL PROCEDURES: PCC Section 18.14.020 (i) states that "A variance decision of the Noise Control Officer or the Noise Review Board may be appealed to the City Council as follows: (1) A variance decision may be appealed by the applicant, his legal representative, or by any person who has submitted oral or written testimony on the application. (2) Notice of intent to appeal shall be submitted in writing to the City Auditor's Office within 10 day of the effective date of the decision. The notice shall identify the decision that is being appealed, and shall include the appellant's name, address and signature, phone number, relationship to the variance decision action, and a clear statement of the specific reason(s) for the appeal including alleged misapplication of City Codes.

(3) Upon receipt of such appeal, the Auditor shall then place the matter upon the Calendar of the City Council. At the time of hearing, the City Council may consider such new matters as it deems appropriate, as well as the record developed before the Noise Control Officer or the Noise Review Board, and thereafter may affirm, reverse, modify or remand the decision".

PARKS VARIANCE for a SERIES OF SUMMER CONCERT AND OUTDOOR MOVIE EVENTS: Jeff Milkes variance number 3631406 for 2015:

They paid one low impact fee of \$83 for the permit. It appears to be more reasonable and equitable to charge one high impact fee of \$366 in looking at this one more closely.

Management had determined that for the routine parks concert and movie type events, we would have them pull one variance for the summer concert season. This is also the same approach we use with the City Wide "Neighborhood Night Out" events that occur in the City. ONI rolls all of their events into one variance request. That variance is an internal request from one ONI entity to another. We do not collect money from the Crime Prevention program on that one.

You may wish to advocate to the Task Force group and ultimately to Commissioner Fritz that we should be charging one permit fee to each event, or some higher rate than we currently charge... I am staying neutral on that topic. This fee was determined as a single fee by folks well above my pay grade. I have profession experience and perspectives on the funding challenges for the Noise Control Office. When I am asked to share those professional perspectives garnered over 25 years of work, I will happily do so. The Task Force is an opportunity for those participating to educate Commissioner Fritz on your perspectives, not mine. I would have no complaints either way if we continue to collect one variance fee for the summer series or one fee for each individual event.

My math shows 152 event dates and locations / times a basic low impact event rate of \$83 = equals \$12,616.


Or if we determine that we are going to charge each event for creating high impact on the community, we will be charging \$366 per event / times 152 = equals \$55,632.

Noise Review Board Testimony

Maryhelen Kincaid 2030 NE Blue Heron Drive Portland, OR 97211

I was the chair of the Port of Portland's Citizen Noise Advisory Committee (CNAC) for 9 years. It is a 15 m3mber committee representing jurisdictions such as counties and cities as well as neighborhood representatives. It is the only all citizen based airport noise committee in the US. We specifically dealt with airplane noise and how it impacted surrounding neighborhoods and the City.

Our charge was to "...act on behalf of local jurisdictions as the official forum to address community noise concerns; review airport noise issues and provide input or recommendations on issue resolution and follow-up action; and develop ideas and recommend proposals for consideration in future airport noise plans.

Not too much different than your charge. We did not have a formal process to "grant variances" but any change in flight paths or operations that would impact the noise impact areas were carefully scrutinized and had to follow strict federal rules and community guidelines.

Our primary role was to advocate for the greatest possible reduction in sound emissions whether they be from aircraft, ground operations, or airport construction noise. There are standards to be met, and Kerrie Standlee was a hired consultant for several PDX Noise Management studies. Paul Van Orden participated in discussions about a noise mapping study and often met with the Port's Noise Management team. There are many agencies that deal with the issues and concerns of noise at PDX. 16 million passengers travel through PDX each year, the population of the surrounding neighborhoods is less than 3% of that. Airlines create billions of dollars in revenue for a lot of people. Federal, State and City regulations all play a part in the management of Noise at PDX. In addition to passenger travel there are cargo planes, both large and small, and military aircraft contributing to the noise impacts. I live 3,500 feet from the west end of the south runway, the longest of 3 at PDX, and the most used. There are 8 neighborhoods that border PDX, that are impacted by the approximately 300 arrivals and departures each day. Anyone ever heard an F-15 military aircraft take off in afterburner?

I can tell you it is nothing compared to the noise and vibrations of impact hammer pile driver operations that affects hundreds of residents living within the impacted construction zone.

Your charge is "...to help establish the direction the City is headed in addressing emerging noise problems in the community. The board is helpful in educating other government agencies about the important role that they can play in helping make Portland a quieter and therefore more livable city"is somewhat similar to CNAC but your approach has been vastly different. I have been puzzled at the difference for the 2 years I have been involved in an attempt to find a reasonable solution to the suffering and egregious health impacts suffered by residents, and visitors, to the Pearl District. It isn't just a few people, it is thousands, and it seems to me you have failed to realize the ill effects that you have been allowing to happen.

After finding it frustrating and confusing to deal with the Noise Office, and attend your meetings, it is citizens like Mary Sipe and Patrice Hansen who contacted developers, informed them of their concerns, had respectable meetings and negotiated the use of the augercast pile driver. The Noise Review Board and the Noise Office did nothing to reach those agreements, or even assist the citizens in becoming informed about construction noise. The Noise Office created a difficult process for reporting complaints, The NRB often refused to hear testimony from citizens with complaints. All of the suggested solutions and actual pleas brought to you, to examine negotiations with contractors over the use of augercast were ignored. The citizens like Mary and Patrice took it upon themselves, with the help of many other neighbors and businesses, to contact the builders/developers and achieved an outcome that was favorable to all.

I attended NRB meetings where members of the public were mocked and ignored by committee members. I heard citizens say "what can we do to help you reduce the noise in the Pearl?" And then hear the response "stop bothering us,

we are busy dealing with variances". You were presented with recommendations and proposed solutions and did nothing. You have, however, granted variances.

The notification of hearings and the variances is better than it was 2 years ago with web access but it is nowhere near useful. The process of notification of the application for a variance, and ability to appeal is burdensome and near impossible for a neighborhood to provide any input.

I was a member of the Noise Task Force and feel as if I, and the others, wasted our time in offering advice and possible solutions. No one ever recommended the NRB make geotechnical decisions.

I do not fault Commissioner Fritz for doing nothing because the very citizen committee she relies on for advice gave her nothing, and no recommendations. I will continue to advocate with City Council members for better solutions for those people who will continue to suffer because of your unwillingness to represent their health and living conditions.

As others have mentioned, this is not, as one of your board members stated, "the narrowminded complaints of a few", it is thousands of people, and the numbers will continue to grow as the construction moves into the highly populated areas of Central City. Lloyd District, and the infill development in inner SE and NE.

I urge you to reconsider the recommendations and thoughtful work of the Noise Task Force. It is the best information you have received. Make this an opportunity to improve the lives of citizens of Portland.

Testimony- Noise Review Board 4/13/2016

The failure of the this Board to support the Pile Driving Variance Process proposed by Commissioner Fritz is both baffling and disturbing to me. Two stated purposes of the board are 1) "to help establish the direction the City is headed in addressing emerging noise problems in the community. And 2) "The board is helpful in educating other government agencies about the important role that they can play in helping make Portland a quieter and therefore more livable city."

Impact hammer pile driving is one of the most egregious, harmful noise polluters in the city as it produces noise and vibration far beyond the decibel levels of most other urban noise sources. Somehow this board continues to believe that the proposal is asking them to make decisions about how a building should be built. Clearly this is not the case. The language of the proposal makes it clear that this would be at the direction of the geotechnical engineer not the Noise Review Board.

What the proposal does do is require builders to use a reasonable, workable, quieter method whenever feasible rather than choosing the method promoted by Dewitt Construction who serves to profit from the use of the particular type of equipment that they have for laying foundations for large buildings, namely the impact hammer. I am sure Dewitt Construction can discover creative ways to continue successfully in business while adopting more equitable noise mitigating practices that benefit everyone when working in densely populated areas.

The change in hours implemented in July is virtually meaningless. Experience has shown that, with setup time included, pile driving most often does not begin until at least 8am so the only benefit is that pile driving cannot happen on Saturdays. I see these code changes as merely an attempt to pacify.

There were concerns about delays in projects with the use of alternatives to the impact hammer. This too is not necessarily the case. For instance, impact hammer pile driving on block 17, for a 17 story building, took 7 weeks. Block 15, using the auger drill, completed the work in 3 to 4 weeks on a 28 story building.

On May 21, Mary Sipe will receive a NW Examiner Community Award due to her work on the pile driving issue which resulted in many developers switching to the quieter auger drill. Last year I received that award for the same issue. Clearly, this is a statement by the bigger community.

I have the sense that the Noise Review Board succumbed to pressures from the construction industry (Dewitt) rather than consider the greater good of the many. I've said before that anyone who thinks the disruption of the impact hammer is just a nuisance, should be required to live across the street from it for a day or two, extrapolate that out to many weeks and then come to a conclusion. Would you want your elderly mother, disabled family member, child, pet or anyone to be subject to that kind of assault?

Another idea is that perhaps when there is a particular issue like, pile driving, there could be a temporary seat made available for someone who is directly being impacted so they can represent community and be included in the meetings that occur after public testimony is completed?

I've heard numerous times from Paul VanOrden how the Noise Office is underfunded and understaffed and how this gets in the way of enforcement. I understand how challenging this can be but to my mind this is when it is important to use creative ideas to find ways to include a community that wants to be involved to assure livability. I'm thinking about the ONI program on Crime Prevention that helps citizens get results by setting up Foot Patrols and the Neighborhood Watch. I'm sure that in regard to noise there are ways that community members can be encouraged to participate and be of help to the Noise Office. What it takes is thinking outside the box and being open to possibilities.

Dear Members of the Noise Review Board:

My name is Dave Mitchell, and my wife and I have lived in the Pearl District for the past six and one-half years since moving here from San Diego. We chose Portland as the home for our retirement years after hearing so many people applaud this city's longstanding commitment to maintaining a superior quality of life.

When my father and mother first took me into midtown Manhattan as a four-year-old in the early 1950s, I was overwhelmed by the loud sounds and sights of high-rise building construction going on everywhere I looked. I remember asking my parents, when is all this construction going to end? My father replied, "Dave, this is what a big city is all about...this activity will go on forever." Dad's comments have stayed with me all these years, which explains in part why I'm here this evening to speak briefly to all of you.

As members of Portland's Noise Review Board, you are charged with the responsibility of developing and maintaining noise standards that balance quality of life concerns with activities that promote economic growth and vitality. By agreeing to serve on this Board, you've assumed a vital role in ensuring that Portland remains a vibrant and attractive city in which to live and work.

At the core of this responsibility is the requirement that you <u>always</u> maintain a delicate balance between those who are economically rewarded for new construction and renovation projects, and those residents and workers who must make temporary and often profound sacrifices to allow for growth and development to occur.

My own experience in dealing with this Board and the Noise Task Force over your recent deliberations involving impact hammer pile driving has led me to conclude that you fundamentally failed in your responsibility to maintain an appropriate balance between quality of life concerns of thousands of residents and the economic interests of a few developers and contractors.

The Noise Task Force and this Board were presented with a golden opportunity to put in place enlightened and well-documented measures modelled after those adopted in New York City, which would have rendered hammer impact pile driving as a <u>last</u> resort

predicated on geophysical imperatives, rather than as the go-to $\underline{\text{first resort}}$ chosen by developers for cost reasons.

Despite what I thought were compelling arguments from various parties, including myself, which argued for stricter regulation of pile driving, the Noise Task Force, this Board, and then Commissioner Fritz elected to maintain the status quo, with <u>no</u> changes that would have curtailed the use of intrusive impact hammer pile driving in projects that would have been perfect candidates for quieter and less disruptive construction techniques such as the continuous augur drill.

As I stated in a letter to Commssioner Fritz following her decision not to make <u>any</u> changes in the codes governing impact pile driving, I felt that your recommendation to her to propose <u>no</u> changes in the existing code was a serious insult to those of us voters and taxpayers who went into the hearing process believing that this Board would deliberate in an equitable and professional manner.

I and others have requested – but we have <u>not</u> received – <u>any</u> explanation whatsoever as to why this Board, or Commissioner Fritz, totally ignored proposals that would have made impact pile driving a last resort rather than a first resort. Frankly, I find this Board's action, and the subsequent action by Commissioner Fritz, on this important matter irresponsible and not at all in keeping with Portland's motto touting itself as "the City that works." In this instance, the City did not work.

It is tempting to conclude that this Board is in the hip pocket of real estate developers and contractors who are interested primarily in generating the greatest profit from their construction and development projects, regardless of how these projects affect the lives of those who live and work nearby. However, I'd prefer to think that this Board is not a puppet of the real estate development sector, and that you do intend to revisit pile driving regulations again in the very near future.

What we've been facing in the Pearl District in terms of the volume of new high-rise construction is a mere drop in the bucket compared with the huge pipeline of new construction projects planned for the central city and elsewhere. I believe that you haven't heard the last word from those of us who remain convinced that you must address the pile driving issue more aggressively as part of your civic responsibilities. This issue is not going to go away; in fact, in coming months, I predict that you're going to be getting an earful of complaints from local residents and workers when you allow impact hammer pile driving to be used when other less disruptive techniques could be employed.

In the meantime, I come away from this process quite disillusioned and disgusted with the way this Board and Commissioner Fritz have handled this matter. This is simply not the way a progressive city government is supposed to work.

I am deeply disappointed by the Noise Review Board's unanimous decision at its March Meeting recommending against noise ordinance changes proposed by Commissioner Amanda Fritz, specifically with reference to impact hammer pile driving.

This decision is a failure in government's basic responsibility to protect the health and well being of the public, a concern that had been so extensively described in various testimonies, discussed during the task force hearings and is a commonly held precept in the safety and health community across the country.

The crux of the issue at hand is a simple one that has been unduly complicated: prohibit impact hammer pile driving except in situations where it is duly certified that other, quieter methods are geotechnical unfeasible. The issues of variance and fees etc. are ancillary to that basic premise and can easily be determined, barring undo resistance from some in the construction and development communities who might have other self interests.

The diligent efforts of a number of citizen's concerned about public health and safety has gone to naught, thus a lost opportunity for improving the livability and quality of life of Portland.

Subject: Proposed Pile Driver Noise Code Changes

My name is Brooks Hickerson and I live at 1255 NW 9th Ave. in a building called the Pinnacle. THE BEAT GOES ON.

In the last three years seven buildings have been constructed within three blocks of my residence. The first three of these buildings used a impact pile driver. The last four buildings used an augur to drill a foundation. I counted over 800 impacts to drive a single pile into the ground, and it can require 200 piles per building foundation. This is more that 160 thousand impacts spread over 6 or 7 weeks at a noise level of 110 decibels. The OSHA standard for maximum allowable noise level for an 8 hour shift is 90 decibels (occupational noise exposure standard 1910.95).

Dr. Charles Liberman's from Harvard Medical School studies pathways between the ear and the brain. His article "Hidden Hearing Loss" in August, 2015, Scientific American describes how the inner ear converts sound energy to nerve impulses that are delivered to our brain. He points out that audiogram, the gold standard for hearing tests, measures inner earn hair cell damage, and it is a very poor measure of auditory nerve damage. Audio nerve damage degrades our ability to understand speech and nerve damage is not repairable. It is your job to protect the citizens of Portland from permanent

hearing loss due to loud noises. Current ordinances allow a builder to create any noise from 8 to 5 Monday through Friday, without any notification of the Noise Control Board or the residents near the building site.

So what are you to do? You have to decide what hearing loss is acceptable to what portion of Portland population?

I believe you should BAN IMPACT PILE DRIVERS outright in residential areas. Then use a variance process when geophysical conditions require such extreme measures that endanger the health of Portland citizens. I also believe you should require any builder proposing to use IMPACT PILE DRIVER foundation to notify all residents within 500 feet, and give them time and place to respond to this assault on their hearing, such as the NRB.

At last month's meeting, Commissioner Fritz presented the Noise Review Board with a clear, concise, fair and easy to administer proposal to require a Noise Variance Permit for impact hammer pile driving which you chose not to support.

Over the past two years, you have heard the same objections to any efforts to limit the unnecessary use of the impact hammer pile driver.

Those objections have been from DeWitt Construction, members of the pile drivers union and Hoyt Street Properties. None of their objections are valid.

DeWitt has maintained that due to soil conditions the quieter auger drill method is not viable in some areas of Portland like the Pearl District. In the last two years more than 10 projects have successfully set foundation piles using the auger drill in the Pearl District. What more proof do you need that the soil conditions do not always prohibit the use of the auger drill?

DeWitt has maintained that noise mitigation devices do not work and can be a safety issue. The Noise Review Board has taken DeWitt at their word and failed to require noise mitigation. Construction noise ordinances in many cities across the US require noise mitigation devices when the impact hammer is used. Noise mitigation devices are available, are being used and work.

I have lived in the Pear District since 2000 and like my neighbors, believed that impact hammer pile driving was a necessary evil of construction.

In May 2014 after suffering through 7 weeks of impact hammer pile driving at the Block 17 project some 100 feet away from the building where we live, a group of residents began to ask if this was a necessary evil of construction. We found that it is not and that quieter auger drill equipment was now available in our area.

When development in the Pearl District began, DeWitt was the only game in town. For a good ten years they used their impact hammer pile drivers to set foundation piles on most of the projects in the Pearl District.

Then in 2012 there was a new game in town, Pacific Foundation. Pacific Foundation has invested in state of the art equipment that is capable of setting deep foundation piles in difficult soil conditions with the use of a quieter auger drill.

When we informed developers of the serious health hazards and potential permanent hearing loss that the impact hammer presented to the children living and playing in the neighborhood they changed their plans to use the impact hammer and all switched to the auger drill. Those developers all contracted with Pacific Foundation. DeWitt lost those jobs because the only equipment they have that is capable of setting the deep piles necessary for those high-rise buildings is their impact hammer.

DeWitt has told you that they have auger drills and that they use the auger on more than 40% of their projects and that they do more auger projects than all of their competition combined.

What they have not told you is that their auger equipment is ancient and is not capable of drilling the 100+ feet necessary to set piles on the 20 & 30 story buildings currently under construction in the Pearl District.

DeWitt is currently setting piles on two projects in our neighborhood. The auger drill they are using is very old and appears to be able to drill only about 25-30 feet into the ground.

The reason that DeWitt does not want any restrictions on the use of the impact hammer pile driver is because the impact hammer is the only equipment that they own that is capable of setting deep piles on high-rise buildings. DeWitt also owns two patents on the impact hammer so they have a vested interest in its use.

At last month's Noise Review Board meeting members of the pile drivers union testified about their fear of loss of work if the use of the impact hammer is restricted. Those fears are completely unfounded. The impact hammer has not been used in the Pearl District for almost two years and the pile driver union members have been gainfully employed on all of the auger drill projects during that time. Jim Brunkhorst from Pacific Foundation testified that they have hired and will continue to hire members of the pile drivers union to work on their auger drill projects as I am sure DeWitt will do. Members of the pile drivers union do not just work on impact hammer jobs, they also work on auger drill jobs.

The other objections you have heard have been from Hoyt Street Properties. Tiffany Sweitzer's claim that the auger "did not work" on Block 15 was completely false. Scott Mills, their geotechnical engineer stated at a 2015 Noise Review Board meeting that the foundation is safe. They have a 28 story high-rise almost complete and ready for occupancy...what did not work? The challenges they encountered on that project were not because they used the auger drill to set pile. They encountered challenges because they were attempting to put a 28 story tower on soil that was unstable. They overcame the challenges by using the auger drill. I seriously doubt that without Pacific Foundation's state-of-the-art equipment, Hoyt Street would have been able to construct that building. Doug Shapiro stated in a Noise Task Force meeting that the auger drill was used on Block 15 because it was the only viable method. The auger drill was not the problem...it was the solution.

In the last two years out of 13 different developers, Hoyt Street is the only developer who has chosen to use the impact hammer. The objections made by Tiffany Sweitzer support my fear that Hoyt Street will use the impact hammer at their new project at Block 20 not because they must but because they can and that once again neighbors will suffer the serious negative physical and psychological effects of this dangerous and unnecessary noise.

The Noise Review Board continues to believe that the proposal is asking them to make decisions about how a building should be built. That is not the case. The language of the proposal makes it clear that this would be at the direction of the geotechnical engineer not the Noise Review Board.

The proposal would allow impact hammer pile driving when geotechnical conditions require its use. The proposal would have simply given the Noise Review Board authority to limit **unnecessary** use of the impact hammer pile driver and at some point require noise mitigation devices.

In her March 24th letter Commissioner Fritz stated:

The Noise Review Board has asked staff to study on-site mitigation strategies utilized in larger cities like New York...and that...ONI staff will work on this project as time allows.

In 2000 a Noise Control Task Force identified pile driving as a serious noise issue and made recommendations to develop an interior decibel standard for pile driving similar to that enacted in Seattle, Washington and allow that standard to be exceeded only between 3 pm and 7 pm. What happened to that recommendation? Here we are 16 years later still talking about pile driving.

I submitted the New York City policy on pile driving to the Noise Control Office in June 2014 when I testified before the City Council. You have had this information for two years...how much more time do you need?

As I understand it, the Noise Control Office was assigned one or two interns during the summer and fall of 2014 to research the New York policy and policies of other US cities. The feedback we received from the Noise Control Office was that they were unable to make contact with NYC. Where is the report of findings resulting from all of the research that has been claimed to have been done by these interns and the Noise Review Board?

The July 2015 amendment to Title 18 restricting use of the impact hammer pile driver to 8 am – 6pm Monday through Friday is laughable. The pile driving we experienced during April and May of 2014 did not start before 8 am and out of 7 weeks they only worked on 3 Saturdays. As DeWitt testified, Saturdays are not normal scheduled workdays, they are make-up days and only used when the project falls behind schedule.

The only reason impact hammer pile driving has not been used in the last two years in the Pearl District is because citizens have taken it upon themselves to convince developers to use the new, quieter auger drill, not because of anything the Noise Review Board has done.

I am deeply disappointed that two years have passed and The Noise Review Board continues to dismiss the true facts in this case and made their decision based on unsubstantiated claims made by people in the industry who stand to gain from the use of the impact hammer pile driver.

Construction activity is not allowed during all federal holidays.

Due to the congestion in Aspen when town is completely full, noise suppression plans will not be approved for the following dates: Christmas Week (December 25 through Jan. 1), Food and Wine Week in June (Friday thru Sunday), 4th of July day and/or weekend if it falls on a Friday or Monday, and Labor Day weekend.

Specific noise suppression requirements for all activities exceeding 80 decibels at a construction site include:

- 1. Notify neighbors within two hundred fifty (300) feet of the project informing them of the kinds of equipment, expected noise levels and durations of loud work. Including the variation of noise levels during a typical construction days may be helpful. Such notification must be in writing and be done seven (7) days prior to the starting time of the project. Communication with neighbors can prevent complaints from arising, and resolve concerns before there is a problem. Provide a phone number where the foreman can be reached prior to the start of the job.
- 2. Operate equipment in accordance with manufacturer's specifications and with all standard manufacturers' mufflers and noise-reducing equipment in use and in properly operating condition.
- 3. Post notices to inform workers, including sub-contractors, about the basic noise requirements, as well as specific noise restrictions, to the project.
- 4. Install noise barriers around all equipment/activities specified in Table 1: TYPICAL CONSTRUCTION EQUIPMENT REQUIRING NOISE SUPPRESSION. Noise barriers not only significantly reduce construction noise, but they also provide an extra benefit of "hiding" the noise producing sources, thus increasing a neighbor's tolerance. (See also the attached list of noise blocking methods for details on approved noise barriers.)
- 5. Move portable loud equipment including generators, compressors, and cement mixers to different sides of the property to reduce impacts on individual neighbors.

What can you do about construction noise?

- The use of radios on the site before 8:00 am are not allowed: remind laborers and subcontractors.
- Noise suppression plans will not allow noisy machines such as brick cutters or jackhammers to be operated before 9.00 am.
- Noisy equipment such as cement mixers should be placed on the site to maximize the
 distance from neighboring houses and/or rotate location so as to not impact just one
 neighbor. Noise levels drop quickly with distance from the source.
- All equipment should be properly maintained, with special attention to mufflers and other noise control devices.
- Between work periods, builders are required by city ordinance to shut down machines such as backhoes, bobcats, loaders and generators.
- When dropping materials from a height—for example, into or out of a truck, or when loading or unloading scaffolding, noise suppression plans require a chute or side baffles.
- All vehicular movements to and from the site must only be made during the scheduled normal working hours. This includes off-site noise that is associated with a specific project such as staging of concrete trucks.

Noise Blocking Methods

Contractors shall require all subcontractors and vendors to use:

- Quieter vs. Louder equipment
- "Residential" grade combustion engine exhaust silencers
- Electrical vs. pneumatic hand power tools: All pneumatic tools operated in the City of Aspen must be fitted with an effective silencer on their air exhaust port.
- Hydraulic vs. air powered rock drills
- "Silenced" pile drivers vs. Diesel pile drivers

In general, noise reduction equipment and materials may include, but not be limited to:

- 1. Shields, shrouds, or intake and exhaust mufflers.
- 2. Noise-deadening material to line hoppers, conveyor transfer points, storage bins, or chutes
- 3. Noise barriers using materials consistent with the Temporary Noise Barrier Materials Section.
- 4. Noise curtains
- 5. Plywood with concrete blankets at the height of the equipment and that it surrounds the activity such that it directs noise up more than out from the property.
- 6. Portable three sided enclosures made out of plywood to move with the activity such as jack hammering.
- 7. Internal combustion engines are to be fitted with a suitable muffler in good repair.

Specific Equipment:

Generators: The local power grid shall be used wherever feasible to limit generator noise. No generators larger than 25 KVA shall be used and, where a generator is necessary, it shall have maximum noise muffling capability.

Backup Alarms: All equipment with backup alarms operated by the Contractor, vendors, suppliers, and subcontractors on the construction site shall be equipped with either audible self-adjusting ambient-sensitive backup alarms or manually-adjustable alarms. The ambient-sensitive alarms shall automatically adjust to a maximum of 5 dBA over the surrounding background noise levels. The manually-adjustable alarms shall be set at the lowest setting required to be audible above the surrounding noise. Installation and use of the alarms shall be consistent with the performance requirements of the current revisions of Society of Automotive Engineering (SAE) J994, J1446, and OSHA regulations.

Compressors: The unit with the lowest noise rating which meets the requirements of the job should be used where work is conducted in the City of Aspen, installed with mufflers and/or enclosed in a noise barrier.

Jackhammer: All jackhammers and pavement breakers used on the construction site shall have exhaust systems and mufflers that have been recommended by the manufacturer as having the lowest associated noise and shall be enclosed with shields or acoustical barrier enclosures.

Concrete crushers or pavement saws: Pre-augur pile holes to reduce the duration of impact or

vibratory pile driving and tie to local power grid to reduce the use of generators and shall be enclosed with shields or acoustical barrier enclosures.

Pneumatic hand power tools: All pneumatic tools operated in the City of Aspen must be fitted

with an effective silencer on their air exhaust port.

Temporary Noise Barrier Materials:

Temporary barriers shall be constructed of 3/4-inch Medium Density Overlay (MDO) plywood sheeting, or other material of equivalent utility and appearance having a surface weight of 2 pounds per square foot or greater. The temporary barriers shall be lined on one side with glass fiber, mineral wool, or other similar noise curtain type noise-absorbing material at least 2-inches. The materials used for temporary barriers shall be sufficient to last through the duration of the construction project, and shall be maintained in good repair. Prefabricated acoustic barriers are available from various vendors. An equivalent barrier design can be submitted in lieu of the plywood barrier described above.

Impact Equipment:

<u>Impact noise</u> is noise produced from impact or devices with discernible separation in sound pressure maxima. Examples for impact equipment include, but are not limited to; blasting, chisel drops, mounted impact hammers (hoe ram), and impact pile drivers.

Impact equipment is the loudest and most intrusive to the neighboring property. The City of Aspen requires that this type activity have the strictest mitigation requirements and requires a customized noise suppression plan specific to the site. General contractors must contact the City of Aspen Environmental Health Department for an application at 970-920-5039.

Noise Control

- Replace worn, loose, or unbalanced machine parts that cause vibration.
- Keep machine parts well lubricated to reduce friction.
- Acoustical enclosures and barriers around generators
- · Sound absorbing material and vibration isolation systems on hand tools
- Quiet work practices use rubber mallets to erect and dismantle formwork.
