HOLD HARMLESS AND AUTHORIZATION & PUBLICATION RELEASE AGREEMENT
HOLD HARMLESS

I _____, desire to participate in activities on City of Portland property and state that I understand the types of activities in which I may participate on Portland Fire & Rescue premises, that I have no impediments to full participation in any activity on City of Portland property and the grounds of its bureau of Portland Fire and Rescue (PF&R), that if I have any concern about participating in any activity on City of Portland property I will so inform PF&R and will refrain from participating in that activity and I agree, that in consideration of the right to attend any activity on City of Portland property, I will hold the City of Portland and its bureau of Portland Fire & Rescue (PF&R), and their respective officers, employees, agents, successors and assigns harmless from any and all claims, demands, actions or suits (including attorney fees) for any illness or injury, including death, which might occur to me, or to another, while I am on PF&R premises or while riding in or on any vehicle or participating as an observer at any fire or emergency operation under the direction of PF&R, unless arising solely out of the willful and wanton negligent acts of the City and its bureau of Portland Fire and Rescue.

PUBLICATION RELEASE

I give and grant to the City of Portland and its bureau of Portland Fire and Rescue, and their officers, employees, agents, its successors, and assigns and any person acting under their permission and authority, the unqualified right, privilege, and permission to use and reproduce images of my participation in any activity on City of Portland property or PF&R grounds in whatever manner taken and in whatever form and to publish and republish the same including any related recordings of my voice, and I hereby grant, assign, and transfer to the City all my rights, and interest therein. In this regard I also waive any right to have prior review or right to object prior to any such publication or use of my images or voice.

I understand that in so doing I am consenting to the use of any and all manner of recording the images of my participation in any activity on City of Portland property or PF&R grounds including but not limited to: 1) still photographs; 2) negatives; 3) digital images; 4) video; 5) CD-ROM; 6) on the Internet; and 7) any other representations of my likeness, regardless of format, singularly or as part of a group or collage, or as part of other materials.

I, for myself, my heirs, executors, administrators and assigns, hereby remise, release, and discharge the City and PF&R, and their officers, employees, agents, successors or assigns, for and from any and all claims of any kind whatsoever on account of the use of such images of me, and recordings of my voice, including but not limited to any and all claims for damages for libel, slander, defamation and invasion right of privacy arising out of such use.
