

City of Portland Code of Conduct for Apparel Contractors Point-of-Assembly Factory Location Form (per brand owner)

INSTRUCTIONS

Prime Contractor: Provide point-of-assembly factory locations for all major contract apparel items supplied to the City (shirts, pants, hats, footwear, coats, outerwear, etc.). You do not need to provide factory locations where decorative items or component materials (e.g. fabric) are manufactured. Submit this form as an attachment to the Prime Contractor Full Compliance Declaration & Verification Form. You may also have this form directly filled out by your suppliers, but as the Prime Contractor with the City, you are responsible for collecting and submitting all applicable factory location information to the City. NOTE: although as the prime contractor you may fill out factory location information, a representative from the apparel manufacturer or brand owner must sign the form acknowledging their compliance with the City's Code of Conduct for Apparel Contractors for the items listed. **Use one form per brand owner.**

Compliance Verification and Disclosure

The City of Portland is a member of the Sweatfree Purchasing Consortium, and as such, the City shares the factory information collected on this form with the Consortium for purposes of compliance verification. The Consortium also uses the information provided to aid its efforts in increasing transparency and accountability in the apparel industry, and as such, will enter the information received from Consortium members into the Consortium's Sweatfree LinkUp online database. Information about where specific products are made is not made public, but information about which factories are used by which brand owner is publicly available through the online database.
