

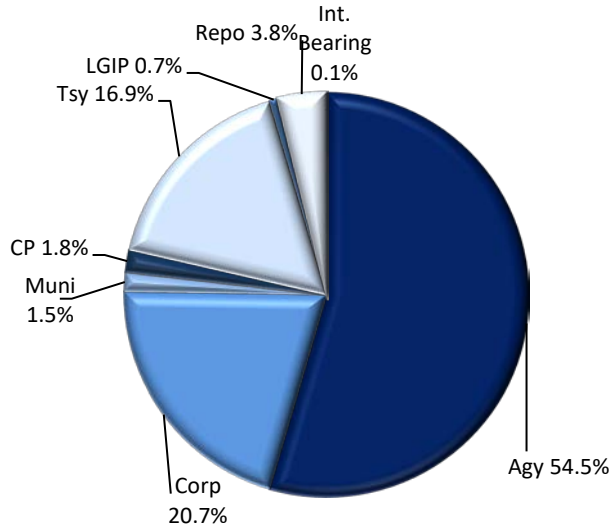

SECTOR ALLOCATION



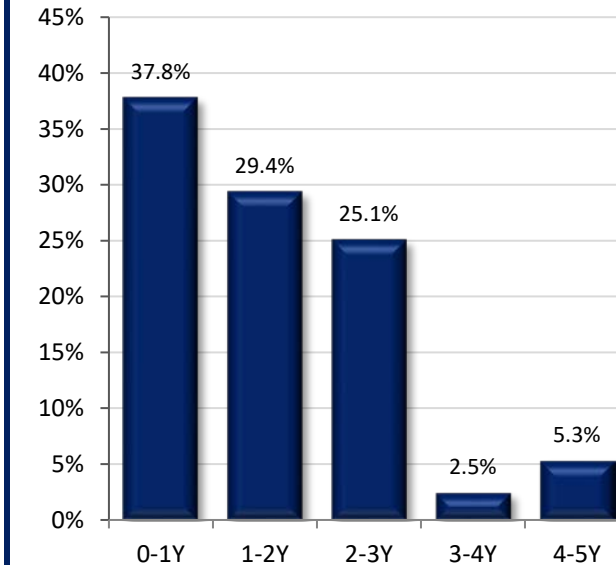

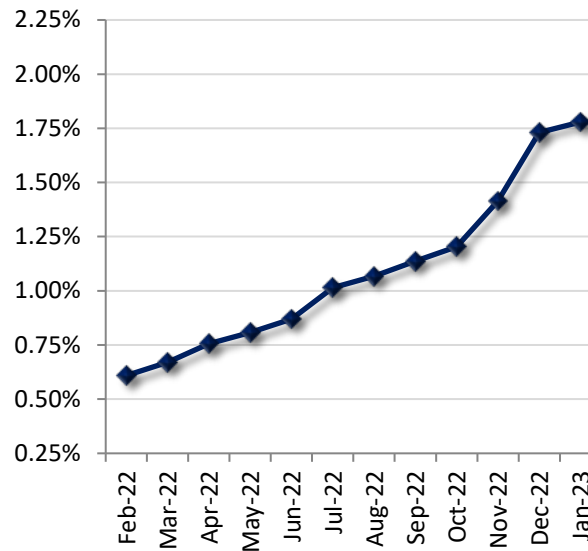

MATURITY DISTRIBUTION



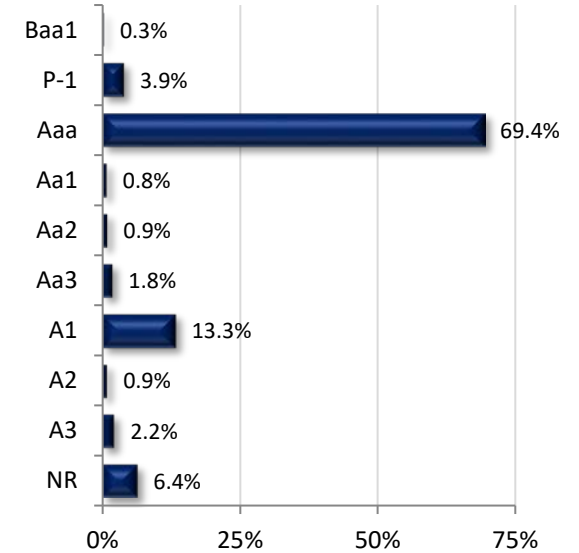
