

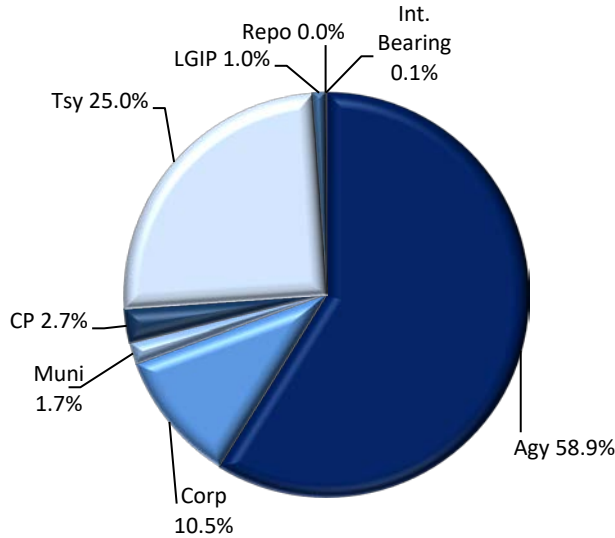

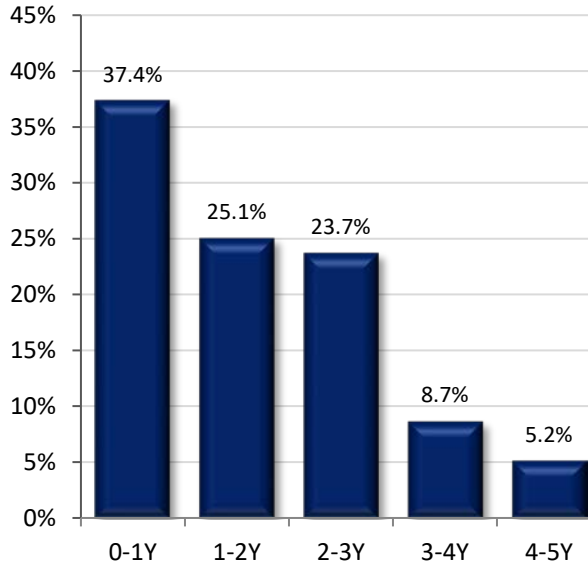

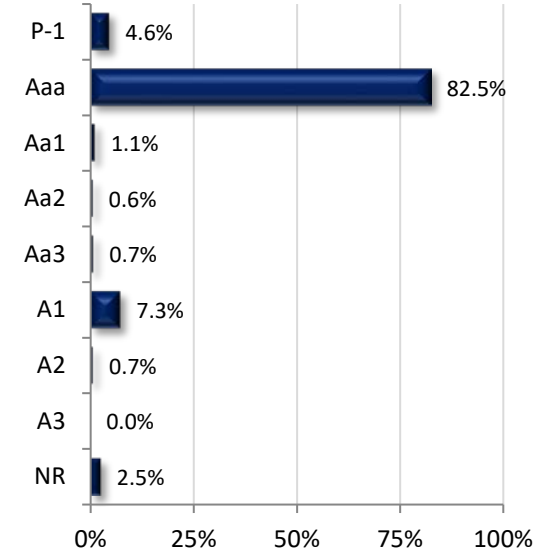
**SECTOR ALLOCATION**

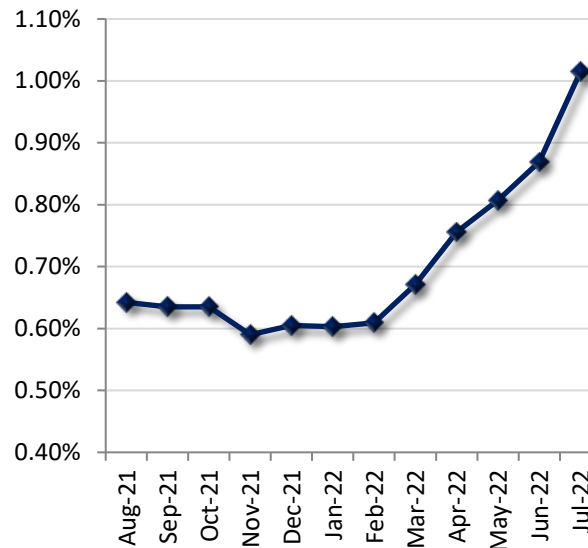
