

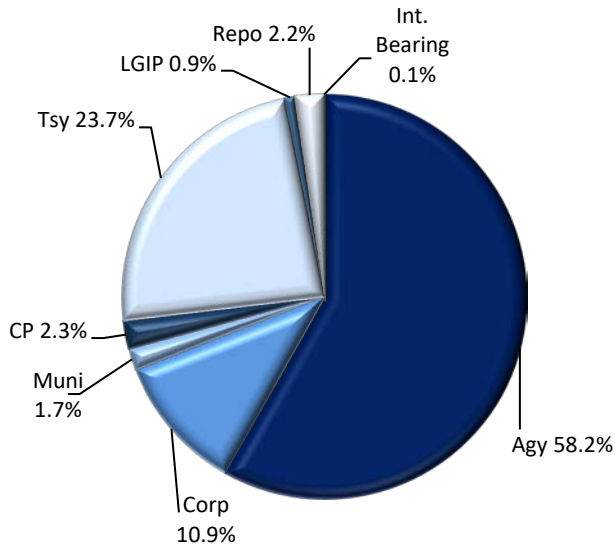

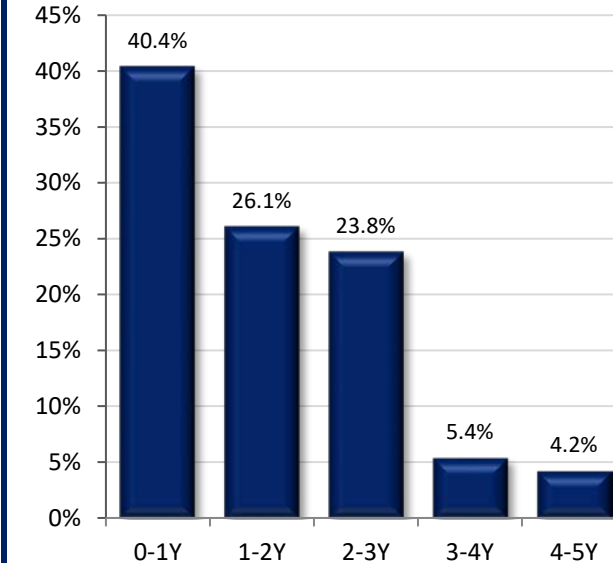

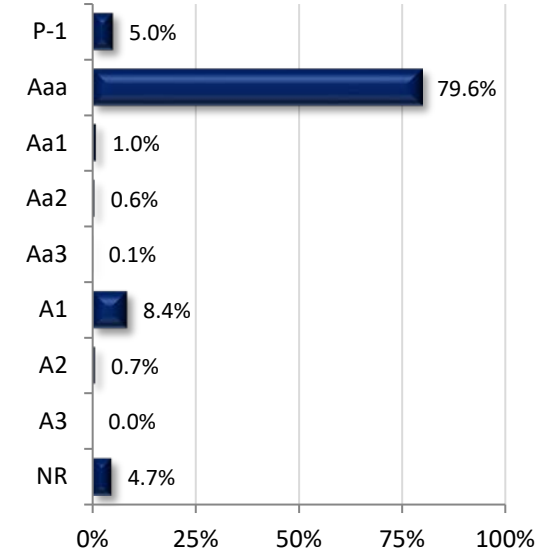
SECTOR ALLOCATION

CREDIT QUALITY (MOODY'S)



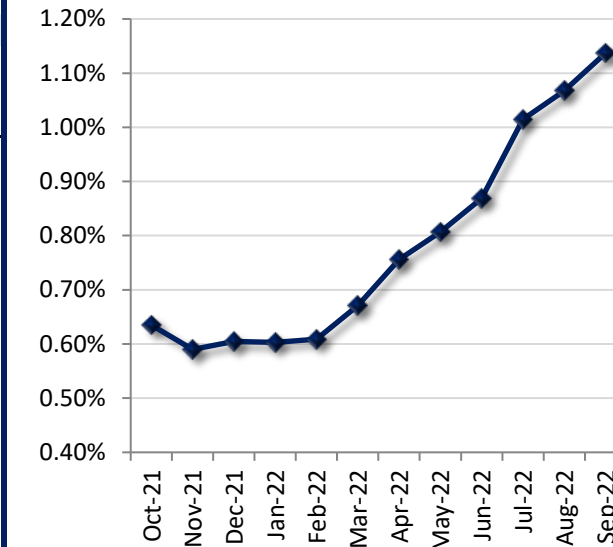
