A group of people that sets rules for the city and supports the communities of the city



What is City Council?

City leaders pass laws and create programs to support the needs of communities

What is a city charter?

- Functions as city's constitution
- Creates city as a legal entity
- Authorizes city powers
- Outlines basic, broad fundamentals of city government
- Concise
- Avoid need for frequent amendment
- Amended by the people




Portland Charter Commission



The Charter Commission is currently reviewing our City Charter to recommend changes that impact **ALL** Portlanders





Role of the Charter Commission


- Determine its own rules of procedure







Form of Government Committee: Study Questions

Legislative Authority: Who should have the power to make the laws?

Executive Authority: Who should have the power to carry out the laws?

Mayor is a member of Council: Should the Mayor be a member of City Council?

Mayor votes with Council: Should the Mayor vote with Council?

Mayor has veto authority: Should the Mayor have veto authority?

Appointment & removal of Chief Administrative Officer or City Manager: Who should be able to appoint and remove a CAO or City Manager?

Appointment & removal of bureau directors: Who should be able to appoint and remove bureau directors?

Policy development: Who should be responsible for developing policy?

Prepare budget: Who should be responsible for preparing the budget?



Form of Government Committee: Areas of Agreement

- Increase the size of City Council
- Remove the role of Commissioner-in-Charge of bureaus from Commissioners and shift the management authority elsewhere
- Cleary (re)define the roles and responsibilities of the Mayor and City Council



City Council Elections



Portland's Current City Council Elections

Constituency

City leaders elected at-large (citywide)

Voting System Winner-take-all (candidate with the most votes wins)

Timing of Elections

Primary (May) & General election (November)





Alternative Constituencies

Districts

Single Member, Multi-Member, or Mixed

At-large

Everyone running in the same pool

Hybrid Both district and at-large



How does STAR voting work?



City Council Elections Committee: Study Questions

Elected offices: Which offices should be elected by the people?

Council constituency: What should the constituency of Councilors be? Examples include atlarge, district, or a mixture of at-large and district. If the Committee recommends districts, how should they be drawn.

Council size: How many City Councilors should we have to fulfill the work of Portland?

Form of voting: What form of voting should we use to elect city elected offices? Should our system retain a winner-take-all/loser has none approach?

Timing of elections: Should we have a two-round system that includes a primary and a general election? Should local elections be aligned with the presidential general election?

Expanding democracy: Who should have the ability to vote on Portland's elected leaders? Who should have the ability to take part in direct democracy ballot measures?

Campaign finance: How can funds be raised and spent? What is the role of public financing?



City Council Elections Committee Areas of Agreement

- Increase the size of City Council
- Shift to a form of voting that allows for a result in one election and captures people's preferences
