Welcome

Allison welcomed everyone and provided meeting logistics.

Approval of Minutes

Group gave thumbs up on the minutes of March 10 and March 15 as submitted.

Extension of Co-Chair terms

Group gave thumbs up on approving extension of term for Commissioners Kitchin and Castaneda to continue as co-chairs until end of April.

Release of public records request

Allison informed the group there was a public records request for the memo of March 2nd from the Attorney's office regarding multi- and single-subject ballot measures. Group did not raise any objections to the release of the memo.

Review Work Session & Identify Discussion Priorities

Co-Chair Castaneda provided an outline of the meeting agenda and reviewed the commission's current timeline. Co-Chair Kitchin provided a summary of the March 24 work session, including the areas of agreement and the topics currently lacking consensus. Group discussed which areas currently lacking consensus they wished to.

Public Input

Audrey Zunkell Decorsey – representing the League of Women Voters of Portland. Thanked the commissioners for their work. Encouraged the commission to consider five reforms: 1) establish council as a legislative body, 2) institute a city manager, 3) increase the number of council members to 10 - 12,

plus the mayor, 4) retain mayor and auditor as citywide positions, elected by ranked choice voting, 5) create multi-member districts elected by ranked choice voting. State that the League of Women voters support a system which elects a council which proportionally represents the people they represent.

Donovan Seymour – supports the current package of potential reforms. Supports multi-member districts, which brings local, community level conversations up to the city council level. This combined with ranked choice voting could lead to an easy voting process. Stated that the mayor should be an executive and have a collaborative relationship with the council. Encouraged the commission to ensure that council has input on the budget to ensure that their legislative priorities are being met.

Terry Harris – stated that the continued pursuit of multi-member districts remains a bad idea. Stated that with the other reforms Portlanders will think they have neighborhood scale representation, and one representative to call their own but that won't occur because the districts will be large, and residents will still have to figure out which of the representatives might return their calls. Stated that with multi-member districts might only bring increased representation to some. Encouraged the commission to instead recommend an increased size of council and single-member districts. Encouraged commission to figure out a process for determining how a Council President would be selected.

Ann Barkley – stated that she is in complete agreement with all proposals except for having four districts with three representatives each. This would lead to "group think" leading to poor decision making. Stated that she does not believe that Portlanders will support this decision. She stated that she is concerned about potential costs of this proposal and whether the commission has heard enough input to make a decision.

Babs Vanelli – is glad the commission is still working through determining the roles of the mayor and council. Stated that she was puzzled by ranked choice voting but after research agrees that is the best method for the commission to propose. Supports increases to size of council and addition of a city manager. Wondered if the commission has considered what mechanism should be in place to modify the system if any changes do not work?

Donna Cohen – Thanked the group for their work. Stated she is a supporter of multi-member proportional representation and of going boldly with the number of districts. Supports ranked choice voting. Believes we need to put funding toward educating the public on these proposals. Stated Portland is out of sync with the numbers of elected representatives (provided examples from Missoula, MT, Roseburg, Oregon). Stated there is a direct connection between higher representation and higher economic success.

Amy Rathfelder – representing the Portland Business Alliance (PBA). Stated the PBA supports agreements of the commission increasing size of council, district-based elections, but has no preference at this time on multi-member districts. The PBA encourages the commission to research the City of Baltimore's experience on multi-member districts. PBA also supports including a city manager who reports to the mayor and prefer ranked choice voting over STAR voting.

Hank Schottland – provided a slideshow regarding ranked choice voting. Ranked Choice Voting involves two components – voting and counting. Voting is simple, counting is not. He stated that explaining the counting process will not be easy and could cause it to be mis-represented or increase the likelihood that this change proposal will fail at the ballot. Suggested that the commission instead propose first three past the post voting and focus on full ranked choice voting reform in a later phase.

Anne-Marie Claire – stated it is most important for Portlanders to be able to vote on form of government and not have voting issues on the same ballot. Believes in geographic, multi-member representation. If elections changes are on the ballot, she believes a mechanism to modify it along the way may be necessary. Also recommends the city manager-form of government with a mayor who votes.

Indigo - representing 350 PDX. Here tonight to explain how climate justice may be impacted by this charter reform. Current commissioners are stretched too thin between constituent and managerial responsibilities. They have also seen institutional knowledge and project momentum lost due to frequent bureau reassignments. 350 PDX supports many preferences of the commission such as a city manager, allow council to act as a true legislative body, increasing council size, establishing multimember districts, and ranked choice voting. Encourage commission to explore ways to move ahead with things such as participatory budgeting and a climate justice subcommittee in phase two.

Discuss and Refine Areas of Agreement

Co-Chair Castaneda reviewed the previously agreed upon desired outcomes for charter reform. He outlined the areas of discussion to help refine the areas of agreement. Allison led the group in a discussion of the following areas still needing agreement.

Mayor votes with council

- From last meeting there appeared to be a majority for mayor voting with council, which functionally makes him the tiebreaker.
- People seem to be nervous about disfunction or slowing of decisions and so need mayor as a tie breaker could alleviate that nervousness.
- How does it make sense to have mayor in executive role but then break that structure so mayor
 can make a legislative decision? This prevents clear lines between legislative and executive
 functions. If we had a deputy mayor, then that person as tie breaker would make sense, but we
 don't. Having mayor break ties would politicize votes unintentionally.
- If mayor votes, they then have extra power in an already more powerful roll. Understand the
 concerns around not wanting disfunction but would rather maintain requirement that if you
 can't get to seven votes, the item doesn't pass. This forces council to negotiate and work
 together.

Straw poll on mayor votes with council – all but one commissioner agree to never.

Mayor veto authority

What happens if council creates policy against Mayor's beliefs?

Group agreed that because last meeting 19 commissioners supported no veto authority, they will move ahead with that decision.

Authority to fire the city manager/administrator

• Absolutely believe that Mayor should be able to fire the city manager/administrator but want 2/3 of Council to also be able to have that authority.

- Agrees with the need for 2/3 Council to have ability to keep city manager/administrator and
 mayor from doing anything illegal together. It's not ideal to have a structure with only one way
 to fire a city manager/administrator.
- Prefer Mayor as only person able to fire, but willing to concede only if higher majority than 2/3 of council can make that decision. The threshold for this action needs to be as high as possible.
- Proposing three-fourths (3/4) threshold (9 out of 12 council members) this would require approval from across all the city districts in some form.
- Appreciate the higher threshold, but 2/3 is actually a pretty high threshold. If 2/3 of council have already lost support of a city manager/administrator, they probably cannot effectively do their job.
- Comes down to perception and what authority the mayor and council have. Would need it to be three-quarters of Council to maintain mayor's authority.
- If want to have a strong mayor, need to give them the authority to hire and fire. Lots of other ways council can control actions of a city manager/administrator
- Agree with Mayor only authority or three-fourths of council.

Straw polls on authority to fire the city manager/ administrator – 16 commissioners indicated support for 'Mayor or 3/4 of council'.

Authority to hire and fire bureau directors

- If you want to have an effective city manager/administrator, they need ability to hire and fire but also need to consult with the mayor. Prefer city manager/administrator decision with input from mayor (i.e. consultation but not approval).
- City manager/administrator role, as we're currently proposing, has the assumption they will have mayor oversight and input because mayor hires/fires the city manager/administrator. Don't want to add additional requirements into the charter language.
- City manager/administrator naturally would contact mayor and council as a practical matter, no need to include additional language in the charter.
- It's important we are not overly proscriptive with charter language.
- We can't assume there will be an even exchange of decision making if we are giving administrative authority to city manager/administrator. Concerned with how much power we are giving to city manager/administrator even though they are meant to be an employee of the mayor.
- Community organizations have been interested in checks and balances on both city manager/administrator and bureau directors. Possibly we need to give direction or strongly encourage there being 360 evaluations with community on those positions.
- Reminder that the structure we're creating means that the city manager/administrator is not just an employee of the mayor they do have to be approved by the council, which is a check on their authority. Hiring and firing is the only power of city manager/administrator. If we aren't careful, we will end up back with council involved in day-to-day management of bureaus. City manager/administrator should have the ability to hire and fire solo, because if they don't perform this well, they will lose their job.
- We have done a good job with checks and balances. Also, we want a city manager/administrator to focus on their skill set maximizing their ability to manage a city and leave the politics to the mayor and council. This authority to remain with the city manager/administrator alone.

- Only concern is the desire to have the city manager/administrator be accountable to the people.
 Concerned we're giving a city manager/administrator a lot of power without any ability of the people to hold them accountable.
- Struggling with the same concern of how to hold the city manager/administrator accountable but also don't want to politicize these decisions.
- Debate on checks and balances is not about input, it is about approval or not approval. Any city
 is going to have checks and balances from community because of elections. Could be okay with
 mayor approval but must have council remain out of the process.
- If Mayor approves it's a strong-mayor form of government I am uncomfortable with it.

Straw poll -18 agreed to city manager/administrator having authority alone (with lots of input from everyone) to hire and fire bureau directors.

Responsibility for budget preparation

- Since Mayor will not vote on council, recommend that the mayor proposes budget and council amends and approves.
- Mayor's budget proposal would be assisted by city manager.
- Ultimately want Council to build the budget based on mayor's proposal.
- Important that we are clear that the mayor presents a budget showing all the things that it takes to achieve council's policy decisions and functions of the city.
- Want to shift more of the power of budget preparation and discussion to the Council.
- Struggle with the notion of council disposing a budget, given the logistics of getting 12 members of a Council navigating the challenge of bringing budgets out of bureaus into a holistic, practical result. Prefer mayor proposes and council amends or approves.
- Don't want the mayor to propose without it being clear that the final product comes from the Council.
- Is it as simple as changing the language to "mayor proposes, council amends and approves"?
- Very concerned with the work done prior to the approval process. Want council to be more involved with shaping of the budget.
- When attorney creates the language based on our proposal, one of the powers of council will be budget approval and they will then determine their own procedures. We don't need to be so proscriptive.
- Amending is a budget is a tremendously huge power and quite a check and balance on the mayor.
- Don't agree that just amending is the same as council having power to define the budget.
- Don't want to be too proscriptive but this is one of the ways to empower the council to respond to the needs of the community. Budgets are moral documents they show what we prioritize and what we care about.
- Knowledge is power how do we get council behind closed doors with directors to talk about outcomes and requirements. We should also raise participatory budgeting for a phase II discussion.
- Support trying to get better language to give council real authority.
- We likely will iterate with the City Attorney on this many times so these discussions are probably better to suited to reacting to draft language.

Straw Poll – Assume that Mayor proposes the budget and council approves, so do you agree that the intention is that council has more power than the mayor on budget? All commissioners agreed.

Number of Districts

- Already a majority of commissioners support four districts and three representatives.
- Would like more than four districts to provide more options for the way districts are drawn, but willing to accept four.
- Don't think four districts is enough, it will be interesting creating the boundaries. It won't serve our goals as well as we want but is better than where we're at now.
- Suspect that once people realize this system is do-able, they will want more than four districts.
- That long view puts me at ease on four districts, even though ideally there should be more.

Straw poll – Are you okay with four districts? All commissioners agreed.

Straw poll – Do you want five districts? 6 commissioners agreed.

Council size

- Appreciate desire for more districts but constraint is that polling has shown 12 is the preferred
 council size. More districts and more representatives does align with our desired outcomes but
 concerns were lower with a council size of 12.
- Agree, but this is all incremental and we need to remain aware of desires stated by the community.
- Is anyone else concerned with unintended consequences of these choices, such as large numbers of people running for office which could increase costs of running for office which are publicly funded, or the need for people to run in a coalition to be elected?
- Have thought about how many people would be running for office, but we don't yet have budget analysis, which will be part of future discussions. Part of what we're desiring is to have a more robust democracy, with more people from different backgrounds being able to run for office. It's a tradeoff worth those concerns.
- Always concerned with the governance side and with this new form of government, there are
 opportunities to find efficiencies which may actually mean there aren't massive increases in
 costs. Four districts with three representatives both gives more opportunities for people to run
 and more opportunities for district offices to better interact with community.
- What we're proposing is new and novel in much of America, but it is common around the world.


