Community Workshop #2 Event and Survey Summary Key Themes & Takeaways

### Community Workshop #2 - January 24, 2023

On January 24, 2023, Portland Parks & Recreation (PP&R) held the second, in a series of five, Community Workshop events for the North Portland Aquatic Center project. The event was hosted at Charles Jordan Community Center (CJCC).

At the event, community members were invited to participate in small group discussions, at round tables of 8-10 people, about where the future state-of-the-art aquatic facility could be built, and what the amenities and programming could look like.

Conversation about the siting of the future facility were rooted in the EQUITY, ACCESS, and IMPACT criteria that has been developed, with community input, since the launch of the project in Spring 2022.







#### Community Workshop #2 - Table Discussions

Each table was asked to evaluate the site criteria and select their "top three" sites (in no particular order). A self-identifying "reporter", at each table then delivered the results to the larger room during the "report out" phase.

# Community Workshop #2 - Survey Summary

A companion survey was launched on January 24, 2023 and remained open until February 12, 2023. Community members were invited to weigh-in on our site selection criteria in three categories (equity, access, and park impact), as well as aquatics programming needs and priorities. The survey received a total of 1,070 survey responses.

#### All Respondents (1,070)

1. Columbia Park: 11.44

2. University Park: 9.61

3. Columbia Park Annex: 9.54

4. Northgate Park: 9.2

5. St. Johns Park: 6.94

\*The cumulative Survey Monkey scores of University Park, Columbia Park Annex, and Northgate Park were within .41 points of one another.




# Community Workshop #2 - Survey Summary






#### NPAC Project Advisory Committee







Across all Focus Groups, University Park and Northgate Park were ranked as the top two sites because of their accessibility and the concentration of communities of color, youth, and low-income families immediately in vicinity. The connectivity and proximity to area schools and other community organizations that serve vulnerable North Portland populations was also a significant factor.
