



INVESTMENTS IN INNER NORTHEAST PORTLAND ANNOUNCED 2013-2018

August 2018 | Since 2013, Parks Commissioner Amanda Fritz and Portland Parks & Recreation have allocated over \$5M in park planning and capital investments in the Northeast Coalition of **Neighbors (NECN) area.** Funded by System Development Charges (SDCs), the Parks Replacement Bond (Bond), General Fund (GF), and in some cases matched by other partners, these investments grow or improve access to, or help maintain, parks and trails. CAPITAL PROJECTS, ACQUISITIONS & PLANNING

#1 ALBERTA PARK HABITAT PATCH

Completed: Spring 2018 **Investment:** \$60K GF + Partners

Info: Forest landscape featuring 6000 plants, accessible gravel path, nurse logs, root wads, boulders, and fencing. Part of PP&R's Ecologically Sustainable Landscape Initiative, these additions add beauty and natural elements to explore while improving habitat for birds and native pollinators. Thanks to Columbia Slough Watershed Council and community volunteers for their work.

#2 FERNHILL PARK SPLASHPAD

Expected Completion: Summer 2018

Investment: \$1.25M (\$750K SDC, \$500K Bond)

Info: Design and construction of splash-pad. Bond Funding used for water line

repairs.









#3 DAWSON PARK PLAY AREA & WATER FEATURE Completed: September 2014

Investment: \$2.73M (\$2.3M TIF, \$230K SDC, \$200K Legacy)

Info: Improved pathways, revived landscape, replaced picnic and play area including new play equipment and upgraded accessible playground surfacing. Interactive water feature thanks to Legacy Emanuel Medical Center. This project was initiated by Commissioner Nick Fish in partnership with Prosper

Portland (then Portland Development Commission).

BOND PROJECTS

#4a MATT DISHMAN COMMUNITY CENTER POOL AND SPA

Completed: October 2016

Investment: \$955,889K (\$748K Bond, \$198K Major Maintenance, \$10K SDCs) Info: Resurfaced the pool and replaced pool filters, expanded spa and replaced

all spa mechanical systems.

#4b MATT DISHMAN COMMUNITY CENTER ROOF & ELECTRICAL **SYSTEMS**

Completed: To be completed Summer 2019

Investment: \$750K Bond

Info: Replaced roof and electrical systems.



ADDITIONAL INVESTMENTS OF NOTE—A new park in previously park deficient area just a few blocks outside the NECN coalition area has been added—Khunamokwst Park in 2015.
