- City Council News
 - [Slide] Proposed Emergency Ordinance to “allow for misdemeanor penalties” for graffiti.
 - “The proposed ordinance aims to address graffiti vandalism applied using public rights-of-way. It prohibits the act of applying spray paint to property within or by utilizing the right-of-way without proper authorization. The proposed ordinance would implement a fine and/or imprisonment for persons found guilty of this offense, and **require a penalty of 7 days of imprisonment** and 50 hours of community service for each violation.” (*Pulled from October 16 Council Agenda*)
 - Currently, the only City ordinance that carries a mandatory minimum sentence is Possession of a Loaded Firearm in a Public Place
- **Review of Recommendation Draft 00:16:50**
 - Odelia shared the background research and work done for this recommendation.
 - [Slide] Stops Data September Meeting Recap
 - Discussion about pretext stops
 - Discussion about benchmarking, racial disparities, and veil of darkness analysis
 - [Slide] What is Veil of Darkness Analysis?
 - Statistical method used to assess potential racial bias in police stops
 - Based on the idea that, during nighttime hours, the visibility of a person’s race or ethnicity decreases.
 - By comparing police stops during daylight to those at night, researchers can evaluate whether racial disparities in stops are influenced by the visibility of race.
 - [Slide] Veil of Darkness Recommendation Draft
 - Recommendation to PPB to add Veil of Darkness Analysis to Annual Stops Data Report, and do retroactive analysis on previous years to establish trend
 - PPB already has data necessary to perform analysis
 - Much discussion over the years about benchmarking and the effort to control for confounding variables. VOD provides opportunity to enhance existing analysis on racial disparities.
 - DaVante Minnieweather and Odelia read through the draft of the recommendation. **00:23:21**
 - PCCEP members asked questions and shared their thoughts on the recommendation draft. **00:31:43**
