Welcome	<ul style="list-style-type: none">• Andrew welcomes everyone to SAPS/ COCL Townhall. Introduces the meeting topics and turns the conversation to the COCL team to present the Townhall on the Compliance and Outcome Assessment Report.
COCL Town Hall	<ul style="list-style-type: none">• The Compliance Officer and Community Liaison (COCL) presents the <u>DRAFT Compliance and Outcome Assessment Quarterly Report: 2019 Updates and Quarter 4 Analysis</u>. The <u>Compliance and Outcome Assessment Report</u> covers the following three areas of the Settlement Agreement:<ul style="list-style-type: none">○ Training○ Officer Accountability○ Community Engagement• Dr. Rosenbaum provides a background of the report – focusing on the systems that are in place that were responsible for the reforms. And rather those systems have remained in place and have not been eliminated or demised by work that has been done since the reforms were put in place.• Dr. Christoff presents on the “Accountability” section of the report. COCL found that PPB and the City of Portland have continued to demonstrate ongoing occurrence to the requirements on the accountability section of the Settlement Agreement. COCL reviewed 20 cases, administrative closures, supervisory investigations, full investigations, Standing Operating Producers (SOPs), and policies, etc.• COCL strongly encourages the City and the community at large to continue supporting the PCCEP after the completion of the Settlement Agreement.• The DOJ found the City in Substantial Compliance effective Jan. 10, 2020, confirming the COCL Assessment.• The City is Required to Stay in Substantial Compliance for at least One Year —“the Maintenance Year”.• PCCEP should continue to evaluate PPB on Community Engagement and the Settlement Agreement.
