SUBJECT
STOLEN FIREARM

On 06/22/2022, at 1156 hrs, I self-dispatched to MDC call to 4108 NE 112th Ave regarding a cold theft of firearm. Upon arrival, I contacted (VI) Deandre TWISS. LEDS listed him as a valid concealed handgun license holder. He explained he last knew to have had his BLK Glock 26 Gen5 on 06/08/2022, at around 0700 hrs. He discovered the semi-automatic handgun missing on 06/20/2022, at around 0600 hrs, when he went to retrieve it from his gun safe inside his residence. He insists the gun was not stolen from the home. The gun's disappearance leads him to believe it was taken from his vehicle, as the safe and the car are the only two places he stores it. However, there was no evidence of forced entry into the vehicle, so it's unclear if the vehicle may have been left unlocked. Ultimately, the gun disappeared under unknown circumstances. (VI) TWISS said the firearm had a loaded ten round magazine that was filled to capacity with brass Magtech 9mm full metal jacket rounds, but that there was no round in the chamber.

(VI) TWISS originally provided the firearm serial #UA2650201, which he read off to me from the gun case for the missing firearm. I provided him with my card referencing the case number and ended my contact. I later searched the provided number in NCIC, which showed the number as "NOT UNIQUE ACCORDING TO NCIC QUALITY CONTROL. ASCERTAIN CORRECT NUMBER," and then showed the same number as stolen firearm in multiple states. Based on the NCIC hit, it is believed the provided number was just a bar code number generic to any Glock 26 Gen5, and not the actual serial number of the firearm. I attempted phone contact with (VI) TWISS, but the original phone number he provided (702-270-0356) was not a working number.

On 06/23/2022, at 1553 hrs, I initiated follow-up call to 4108 NE 112th Ave. Upon arrival, I contacted (VI) TWISS, and verified a correct phone number (725-270-0356). When I mentioned the incorrect serial number, he went and retrieved the gun case and showed it to me. Another number on the case was #ADGT513. (VI) TWISS stated he purchased the firearm from Keith's Sporting Goods about 2 years ago, but no longer has the purchase receipt. (VI) TWISS gave me verbal consent to look in the gun case, but no purchasing documentation was found. (VI) TWISS allowed me to take the gun case to be returned to him once the firearm is recovered. I provided him with a receipt for the item (Property/Evidence Receipt #A224506), and the case was later placed in the North Precinct property room as Evidence. I searched the updated serial number in VCAD, and no stolen alerts were located.

I notified Teletype #91755 of the stolen firearm report.
