BPA (Life Safety, Water, Urban Forestry) Project Updates Erika Lopez and Ellen Weeks

Business process analysis (BPA)

- To date, BPA has been completed with: Life safety, water, and urban forestry.
- The process:
 - Take groups of diverse experience levels.
 - All levels of reviewers and supervisors.
- 4 hours in one day to decide what business process they want to look at and scope; review process from a handoff perspective on how process moves along.
- Look back at process and think about goals and features they want to see in future.
- Invite the TTCI group to participate and a representative from Permitting Services.
- Work together and come up with new process that is more satisfying to customer and reviewers with a better timeline and makes more sense.
- Findings could be anywhere from a fix in technology, minor or major, or policy, HR related, duplicate steps/inefficiency.
- They have had success. Life Safety BPA is 90% complete. Results of findings being shared with full team next week. Then the next steps are to implement the changes.
- Time required per group: 6 hours a week.
- Will pause after Urban Forestry because the city is having changes and need to be considerate of time.
- The process is in person; get people together in a room to share ideas, white boards and sticky notes, group activities.
- Survey folks right after process; so far has been positive and they take the critical to make improvements; they leave feeling engaged and connected.
- Chose to work with Water first because of IA project. BPS and PBOT are organized similarly, and Water and Urban Forestry are organized similarly. Looking to create a more standardized process for these 4 groups.
- Action Item: Jaimeleigh Check in with this group and see if they'd like to share out in April

Easier Uploads Project

Goal of project: Working to eliminate HCP Anywhere process (link you receive to give corrections)

Project outcome slides (see slide deck attached on March and April event page)

• Easier uploads will have: confirmation of uploads, automated review windows, a link that won't expire, and transparent Checksheets in DevHub.

- The end goal is to have DevHub be a complete tool; a more centralized space for customers by reducing systems.
- Easier Uploads is an improvement step, moving towards ProjectDox.
- Automating communication in AMANDA rather than Outlook.
- Not replacing Single PDF Process but improving it.
- Steps:
 - Phase 1: Uploads
 - Phase 2: Review Windows

Lila is looking for feedback from DRAC PITSC group on initial design

- Wants time in this space or separate space to go through discoveries.
- Looking for those with a couple hours of availability to participate in design sessions in April.
- User Acceptance Testing and feedback.
- Are there other customer groups who should be participating?

Questions from PITSC group:

- 1. What's the current thinking/plan for not rolling out with full ProjectDox since it paused during the pandemic?
 - a. BDS is planning on rolling it out. They are shadowing other groups to make decisions.
 - b. Easier Uploads work is positioning them/stage setting to transfer into ProjectDox roll out.
 - c. The rollout of ProjectDox will require deep assessment of business process. Need to consider change management.
 - d. Want to use the Easier Uploads as a stop gap before rolling out full PDOX.
 - i. When developing DevHub side, keeping in mind the path laying for ProjectDox. Want the transition to ProjectDox to be comfortable and familiar.
- 2. Feedback: Folks who—Invite users who submit applications often and frequently for UA testing and feedback on Easier Uploads.
