Credit computed on line 15 is the allowable credit for the 5^{th} consecutive year of credit taken, otherwise, take the allowed credit as appropriate for the 1^{st} , 2^{nd} , 3^{rd} and 4^{th} year of credit from lines 16, 16a or 16b.
