### Instructions

#### Online Payments

You may make payments directly online at [Pro.Portland.gov](http://Pro.Portland.gov). If you are paying online, do not submit this form.

**Note:** Payments sent with your return do **not** require a voucher.

#### Use this voucher only for the following payments:

- Estimated quarterly tax payments.
- Tax due on the original return due date if you are filing an extension.
- Tax due sent separately from a return. If you are mailing your payment without a return, please see the payment and mailing information section.

#### Do not use this voucher if:

- Payment is sent electronically.
- Payment is included when you file your original or amended return. If you are mailing a payment with your return, send the payment and return in the same envelope to the mailing address provided on the return.

#### Required for accurate processing:

- Fill in the tax year for which you are making a payment.
- Enter your SSN (Social Security Number). Enter your spouse's SSN if you are filing a joint return.
- Check the appropriate box for the type of payment being made.

- Check the appropriate box for the tax program for which you are paying.
- If you are remitting a payment for more than one tax program, please enclose a separate voucher and check for each. Mail the vouchers and checks in the same envelope to the mailing address below.

#### Payment Information

Make your check payable to City of Portland. To ensure proper credit to your account, include the taxpayer's name, SSN, tax program (Metro SHS or Multnomah County PFA), and tax year on your check.

#### Note:

The submission of an extension payment by the original return due date provides an automatic six-month extension for the associated tax return. If you do not have a tax balance due but would like to file an extension, your Federal and/or State extension will serve as your Metro and/or Multnomah County extension. When filing your return on the extended due date, check the "Extension Filed" box on the return. If no extension payment was made, please attach a copy of your Federal or State extension with your return.
