(Typical)

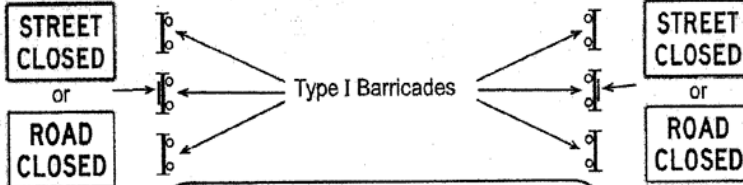
Traffic Control Devices needed to close one typical block:

- 6- Type I Barricades
- 2- **STREET CLOSED** or **ROAD CLOSED** signs:
30" x 24" min. size

Applicant to identify streets by name and indicate the direction of north with an arrow.

Barricades must be equipped with flashing yellow lights at dusk.


