

# Ewe Covid-19 Eviction Moratorium ika ewe mochomochen fansoun ar repwe akaunoi ekkewe sou fenu ar repwe tongeni atouwok me non neniom ewe. Ekkewe 5-Step ren epetin ekkewe chon nonom

## **STEP 1: Kopwe Sinei Omw Pwung**

Ewe Oregon Legislature aa passini ew anuk pwe ekkewe soufenu (Landlords) non Oregon resapw fori ekkei metoch tori fan **October 1**:

1. resapw mak ngonuk ren taropwen omw kopwene tou seni neniom ren omw kose menatiw omw rent ika ren omw niwinimang ngenir seni nefinen ewe April 1 tori September 30;
2. resapw pwan mak ngonuk taropwen omw kopwene tou nge eseor pwopwun me wewen;
3. kopwe asinesin ngeni ekkewe agencies ren omw rent ese kamotiw; ika
4. omw ewe kapachen men rent ren an ese kamotiw

Ika pwe aa wesino ewe eviction moratorium ika ewe mochomochen fansoun ar akaunoi an ekkewe soufenu repwe atokou me non neniom fan October 1, iwe ra ngonuk tori March 31, 2021 omw kopwene ekieki omw kopwe menatiw omw rent ika omw kewe men rent kose meni non ekkewe maram aa no seni fan ewe April ngeni October 2020. Nge ekkewe soufenu (landlords) ir mi tongeni asinesin ngonuk ren ar repwene atouwok ika fen pwan file ini taropwen omw kopwe tou me mwan ika me mwirin ewe moratorium. En mi tongeni kopwe angei pwan kinikinin ekkoch ekkei porous seni [OregonLawHelp.org](https://www.oregonlawhelp.org).

**STEP 2: Makkei ngeni noum ewe soufenu (landlord)** ika pwe ka ekieki nge esapw chiwen me ngonuk omw rent, ureni non taropwe iwe ka pwan isoni eoch noum kapi (copy). Mi fokkun chomong aninis me program ir mi tongeni anisuk ren omw rent ika pwe ka mang won omw rent. Tingor aninis iei chok.

## **STEP 3: Kokori 2-1-1 ika teta won 211.info.org**

Ika fen fos ngeni ewe [Community Action Agency \(CAA\)](https://www.communityactionagency.org) unukum. En mi tongeni tufichin angei ar aninis ar repwe tongeni anisuk ren omw rent, men fifi, me pwan ekkoch pekkinon. Mi free an CAAs repwe kuta ngonuk kinikinin aninis ren ian kopwe tongeni kuna me ian. Pwokiten mi fokkun chomong aramas ir mi tingor aninis, ina ren epwe or ew fansoun omw kopwe utiwitino ren an epwe tori omw fansoun ar repwe tongeni anisuk.

## **STEP 4: Ioni ekkoch porous**

kapach ngeni an state me federal aninis, ekkoch program non neniom, ekkewe non-profits, me ekkewe fan ir mi pwan tongeni anisuk ren. Pwan ew, en mi tongeni kopwe fos ngeni noum ewe soufenu ren omw kopwe memenatiw ekis omw rent. Ei nge pwisin omw finata ika ke mochen, ren chok pekin an epwe kukunutiw omw ewe men rent ika pwe aa tori ewe fansoun (March 2021) an kopwene menatiw unusan omw ewe rent nge esapw chiwen kon watte ika pwe ke memenatiw ekis me ekis. Ekkei porous mi chok fokkun sisiwin, ina pwata fifiti kich me katon news seni ewe [Governor's office](https://www.governor.oregon.gov), [state agencies](https://www.oregon.gov), me ekkewe trusted organizations ika ekkewe mwicheich kich mi fokkun nuku.

mak ngonuk ika asinesin ngonuk ren an epwene awesi noumi taropwen contract fengen ren omw kose menatiw omw ewe rent minen October, iwe mwirin aa pwan file ini ewe taropwen omw kopwe tou me non neniom ika pwe kose menatiw omw rent. En mi pwan tongeni angei taropwe seni noum ewe soufenu ren omw kopwe asinesin ngeni ika pwe kopwe menatiw omw kewe nusun niwinimangen rent non ei 6-maramen grace period. Nge ena soufenu ina epwe ngonuk 14 ran omw kopwe penuwani noum na taropwe. **Kopwe mak ngeni noumna soufenu ka ureni ika pwe kopwe aea ena grace period ika ena mochomochon fansoun omw kopwe menatiw omw ewe rent ren an epwe me kaino omw ewe nusun rent ese kamotiw.** (Ekkwan mwirino omw kopwe mak ngeni, pwe kopwe pwan isoni echo noum kapi.)
