<b>Commercial Mechanical Permit Fee</b>	
For commercial installation, replacement or relocation of non-portable mechanical equipment or mechanical work.	
Valuation:	\$1 to \$1,000 \$110 minimum fee
	\$1,001 to \$10,000 \$110 plus \$2.31 for each additional \$100 over \$1,000
	\$10,001 to \$100,000 \$317.90 plus \$14.20 for each additional \$1,000 over \$10,000
	\$100,001 and above \$1,595.90 plus \$9.73 for each additional \$1,000 over \$100,000
Valuation includes the dollar value of all mechanical materials, equipment, labor overhead and profit.

<b>Field Issuance Remodel Program</b> For 1 & 2 family dwelling alterations/remodels.	
Registration Fee:	\$350 per contractor
Annual Renewal Fee:	\$100
Inspection, plan review, administrative and, project management activities.	\$220 per hour or fraction of an hour Minimum - 1 hour for each inspection
Fees for services provided by bureaus other than the Bureau of Development Services necessary for construction authorization will be billed to the Owner as assessed by those bureaus.	
Fees shall be billed monthly. Fees not paid within 30 days of billing shall be assessed a 5% penalty fee for each 30-day period until paid in full.	
<b>Inspections Outside of Normal Business Hours</b>	\$210 per hour or fraction of an hour Minimum - \$210
<b>Investigation Fee</b> For commencement of work before obtaining a permit.	\$110 per hour or fraction of an hour Minimum - \$110
<b>Master Permit/Facility Permit Program</b> Inspection, plan review, and administrative activities	\$220 per hour or fraction of an hour Minimum - 1 hour for each inspection
<b>Minimum Fee</b>	\$110
<b>Minor Mechanical Labels</b>	
Commercial	\$380 per set of 10 labels
Residential	\$380 per set of 10 labels
<b>Other Inspections Not Specifically Identified Elsewhere</b>	\$155 per hour or fraction of hour Minimum - \$155
<b>Permit Reactivation Processing Fee</b> Fee for renewal of a permit that has been expired, provided no changes have been made to the original plans and specifications for such work. A permit may be renewed only once.	The renewal fee shall be one half the amount required for a new permit.  Minimum Fee - \$155
<b>Reinspection Fee</b>	\$110 per inspection
<b>Requested Inspection Fee</b>	
One and Two-Family Dwellings	\$167
Apartment Houses	\$220 + \$15 for each dwelling unit in excess of three
Hotels/Motels	\$220 + \$10 for each sleeping room in excess of five
All other occupancies one and two stories in height up to 10,000 square feet	\$220 + \$15 for each additional 1,000 square feet
All other occupancies 3 stories in height and above	\$220 + \$27 for each story in excess of three
