Role & Responsibility of a Transportation Ambassador

The Portland Bureau of Transportation strives to ensure that all residents and visitors to Portland are treated with respect and provided with accurate information and advice on getting around Portland. To that end, I, as a Transportation Ambassador, will:

1. Respectfully and courteously represent the City of Portland Bureau of Transportation to all members of the public encountered before, during and after events/activities;
2. Arrive on time to scheduled events/activities;
3. If I am going to be absent or late to scheduled activities I will contact the staff lead at least 2 business days prior to the activity whenever possible;

Role & Responsibility of Staff to Ambassadors

The primary concern of the City of Portland Bureau of Transportation for the Transportation Ambassadors is that the Ambassador and City staff are all treated with respect and are provided the tools and resources needed to have a positive and productive experience. To that end Active Transportation staff will:

1. Schedule an Ambassador to work with at least one Active Transportation or other City employee, intern, or partner Community Based Organization representative at all events/activities;
2. Provide training for volunteers through on-site or virtual Ambassador Training, and other formal and informal training opportunities;

3. Screen activities to make sure that the events/activities will provide a good opportunity to get transportation information out to relevant audiences;
4. Have a cell phone at in-person activities to ensure smooth logistics and communications;
5. Be responsible for providing materials/brochures/maps or other relevant materials to support Ambassadors;
6. Strive to create a fun, safe and enjoyable volunteer experience for Ambassadors.
