A. VACCINE NEWS AND RESOURCES

CITY EMPLOYEE VACCINATION UPDATE

Using an equity framework, OHA is currently distributing COVID-19 vaccine in line with the phased approach recommended by CDC's Advisory Committee on Immunization Practice (ACIP), outlined in Oregon's Vaccination Program (<https://govstatus.egov.com/OR-OHA-COVID-19>). Neither the City (nor any other employer) has authority to determine their own prioritization categories.

- **As of April 19, 16 and 17-year-olds are now eligible to receive the Pfizer Vaccine.**
- **Multnomah County will be offering vaccine clinics for frontline workers that work for local public jurisdictions, over the next two weeks. Sign up information will be shared directly with the 754 City frontline workers who have indicated they would still like access to a vaccine.**

Even after City employees begin receiving vaccinations, the [City's face covering directive](#) will remain in effect. Always continue wearing face coverings when working indoors, and when in the presence of others while working outside. Never come to work when experiencing illness symptoms. Speak up when colleagues are not following these directives. We are all responsible for our workplace safety culture.

Washington Residents

- As of April 15, Washington state's vaccine eligibility includes all Washingtonians 16 years of age and older.
- As of March 22, Washington state is in Phase 3 of its Roadmap to Recovery plan, which includes updated sports guidance.
- As of March 17, Washington state is in Tier 2 of Phase 1B of its vaccine distribution plan; Tier 2 includes workers in agriculture, food processing, grocery stores, public transit, firefighters and law enforcement, as well as those 16 years or older who are both pregnant and have a high-risk disability, and others.
- In Washington the vaccine is available to anyone 65 and older, and all people 50 and older who also live in a multigenerational household. This is in addition to populations eligible during phase 1A including health care workers at high risk for COVID-19 infection, first responders, people who live or work in long-term care facilities, and all other workers in health settings who are at risk of COVID-19.
- Residents must have proof of eligibility for COVID-19 vaccine before approaching any provider.




Oregon's Vaccination Trend: Doses Administered by Day as of April 20.



OVERVIEW

All Oregonians 16 years and older are now eligible to receive a COVID-19 vaccine; As mask mandates end, Oregon OSHA is proposing a permanent rule; New Texas COVID-19 variant resistant to antibodies, researchers say.

- As of April 20, there are 255 confirmed coronavirus hospitalizations in Oregon. The [Oregon Health Authority \(OHA\)](#) releases these numbers daily.
- On April 23, [Governor Kate Brown announced](#) updates to county risk levels starting April 23. There are now 23 counties in High Risk level, three in moderate risk level and ten in lower risk level. Multnomah and Clackamas Counties remain in high risk levels and Washington County moves from moderate risk level to high risk level.
