

City Gun Violence Reduction Grant

FY 2021-22 Funding Application



The Office of Violence Prevention (OVP) addresses the complex factors that drive violence in our city. Our core mission is to reduce violence in Portland. The Office of Violence Prevention provides strategic direction and oversight for City efforts to reduce risk of violence through linked strategies in partnership with government, non-profit, neighborhood, and faith organizations. Families and communities will be safer and more secure, supported, and healthy because of a coalition being actively involved in meaningful violence prevention efforts.

OVP views gun violence as a public health issue, because not only does it cause injury and death, but it also erodes the physical, psychological, social, and economic health and development of nearly everyone in affected communities. Gun violence reduces life expectancy, inflicts trauma, limits opportunity and achievement, and further entrenches inequities. The public health approach views violence as an infectious disease that is treatable and preventable, using tools that have been used to reduce the spread of other “infectious” conditions across human history. This approach is multi-disciplinary and requires a multi-sector partnership. Although there is much emphasis on the immediate reduction of the gun violence impacting our communities, the public health approach also understands that working upstream, focused on primary prevention at the community (rather than individual) level, also inevitably requires medium- and long-term time frames.

The goal for OVP's FY2021-22 Gun Violence Reduction Grants is to reduce gun violence in both the near and long term. Our shared public health model demonstrates this goal can be achieved by implementing evidenced based violence prevention strategies in both upstream (primary preventions) and downstream (secondary and tertiary preventions) lanes of prevention.

The City encourages proposals that will emphasize a culturally responsive plan of support and intervention for communities that have been disproportionately impacted by gun violence (African American/Black, African Immigrant/Refugee, API, Indigenous Americans, and Latinx communities). The City is searching for innovative and new ways to address gun violence that centers communities directly impacted and involved. For that reason, we encourage proposals that will provide services in areas not traditionally in this field; examples are early education and/or healthcare. Preference will be given to those organizations that successfully reflect the aforementioned grant requirements and who have no prior or current grants with the Office of Violence Prevention.

Technical assistance will be provided as identified by those organizations which are new and emerging.

Overview of FY 2021-22 Gun Violence Reduction Grant Application Process

1. Who can apply for the Gun Violence Reduction Grant?

- a. Eligible applicants include small/emerging contractors/community-based organizations—those without current Office of Violence Prevention grant agreements.

(**Note:** Entities that have previously received Gun Violence Reduction Grant funding are not eligible to apply for funds under this solicitation.)

2. How much funding is available through the FY 2021/22 Gun Violence Reduction Grants program?

A total of \$600,000 is available in the City's Gun Violence Reduction Funds (Ordinance 190355). Each grant may vary in range based on the scope of work submitted and number of community members served.

Note: Due to the limited availability of funds, applicants are strongly encouraged to only request the amount of funding necessary for direct program activities so OVP can maximize available resources.

3. What types of programs and activities can be supported through this grant program? Investments should resource the following activities:

- Early Youth Mentoring programs
- Community/Place-based prevention programs
- Mental Health/Cognitive Behavioral Therapy
- Intervention case management
- Flexible funds for wraparound support/services
- Aftercare support funds for families of victims
- Capacity building in small contractors to provide services
- Mentorship for those returning from incarceration
- Youth and adult mediation programs
- De-escalation training
- Shame reduction/Conflict resolution programs
- Arts & Culture Violence prevention programs

4. No award under the competitive Gun Violence Reduction Grant Fund shall exceed \$200,000.

Objectives

Primary Prevention Programs Overall Objective:

The goal of primary prevention work is to prevent violence before it occurs. This is also referred to as “going up-stream to address root causes.” These programs start by identifying the *populations and areas* that are at-risk of over-exposure to violence through multiple social determinants, such as *Education, Family/Peer Health, Behavioral health, Housing, Community Violence, and Economic Development*. These programs focus on evidenced based practices proven to reduce violence such as *Mentoring programs, Pro-social activities, Placemaking endeavors, Trauma-informed care* that intentionally focuses on reducing risk factors and increase protective factors. These programs explicitly seek to reduce gun violence in target populations and area/hot spots by 15% over a 3–5-year period in conjunction with partnering agencies, governmental agencies with a shared primary prevention strategy that addresses root causes and looks for a long-term reduction in violence.

Program Objectives:

- Reduce gun violence using pro-active prevention methods designed to stop the violence before it occurs.
- Programs that focus on increasing protective factors, such as education, family systems, housing programs, medical and behavioral health access, and support.
- Community building vibrancy programming (ex. Arts & Culture prevention programs - murals, music, and theatre) for gun violence education and advocacy.
- Utilize restorative justice practices to support healing and care for communities in efforts to prevent further harm.
- Utilize culturally specific service models that are grounded in the best evidence-based practices for each community.
- Utilize and build community relationships to prevent events and activities that may have a high risk for conflict and/or violence.
- Assist in de-escalation, redirection and prevention at school events/activities, parks, community events, high traffic transit areas, and/or any other areas where individuals who have been deemed high risk may be known to gather.
- Utilize crime prevention strategies by environmental design to change the landscape and climate of spaces to reduce the repeated exposure to violence within communities.

Secondary Prevention Programs Overall Objective:

Secondary violence prevention focuses on treating immediate injury and harm resulting from violent incidents. Early Interventions or response to an immediate threat of violence/conflict involves assistance for individuals who are at the highest risk for violence victimization or offense. Intensive case management programs that utilize credible messengers to provide services that encompass Cognitive Behavioral therapy, Trauma informed care and conflict-mediation services are examples of such assistance. The goal is to reduce gun violence in the near term.

Program Objectives:

- Through a Justice, Equity, Diversity, and Inclusion (JEDI) lens, reduce gun violence in the near term using intensive case management prevention methods designed to stop violence.
- Provide individual services that will be aligned to individual client's needs. Services include safety plans, relocation, ongoing intensive one-on-one case management.
- Provide culturally specific trauma-informed support with connections to appropriate wrap-around services.
- Provide stabilization support services for individuals and families in a quick and timely manner.
- Utilize restorative justice practices to support healing and care for individuals, families, and communities in efforts to prevent further harm.
- Utilize Credible messengers with lived experience and expertise to provide service for the highest risk individuals being served.
- Deter, interrupt, and reduce recidivism and revictimization.
- Focus and establish the building of strong relationships that go beyond service brokering.
- Clients served obtain mental health support, economic development, life plan and an expanded support system.

The GVR Grant Selection Panel is comprised of representatives from OVP, Office of Management and Finance, Council Offices, and the Community, which is tasked with reviewing applications based on the criteria below and making recommendations of awards. The committee will meet weekly to review each application, focusing on the ability of the organization and the grant project/program to address the City’s measures of success and equity goals, as discussed in *Section 3, Project/Program Narrative*. Applicants will be notified by **Monday, December 27, 2021** whether their application was selected for funding. (Note that this day may be subject to change)


