

Air Emissions Permit types	Description
Simple ACDP	Issued for any of 89 industrial processes or manufacturing activities unless a General ACDP is available for the source. A Simple ACDP is based on "generic plant site emission limits" and requires testing and monitoring as well as a description of the measures taken on site to reduce or manage air pollutants.
Standard ACDP	Issued on the basis of a site-specific assessment of emission levels. Permit holders include incinerators for hazardous waste; large manufacturers of paint or asphalt roofing; steel rolling plants; cement plants; large food processors or bakeries; and fuel terminals.
Title V	Administered by DEQ under the authority of Title V of the federal Clean Air Act, Title V permits are held by facilities such as large fuel terminals and major industrial and manufacturing facilities. Permits are issued based on extensive analysis of site-specific operational scenarios, including an evaluation of pollution-control options.
