Notice of Violation and Penalty

The City Auditor's Office conducted a review of the 2020 fourth quarter lobbying activity report submitted by Portland Business Alliance (Alliance) and finds the Alliance failed to report multiple lobbying contacts with City officials, as required by Portland City Code Chapter 2.12 (Regulation of Lobbying Entities).

As a result, the Alliance is fined \$450.00 due on May 10, 2021, and the Auditor's Office recommends that Alliance staff participate in training to ensure future compliance with lobbying regulations.

Background:

On January 15, 2021, the Alliance filed a 2020 fourth quarter lobbying disclosure report with the City. The filed report confirmed the Alliance was subject to City lobbying disclosure regulations because of spending \$1,000 or more on lobbying efforts in the quarter. The regulations required the Alliance to disclose all fourth quarter lobbying contacts with City officials, including those by email and telephone. See City Code 2.12.040. On February 3, 2021, the Auditor's Office received an inquiry from a member of the public regarding a seeming lack of emails included on the Alliance's fourth quarter report. In response, the Auditor's Office opened a review.

2020 Fourth Quarter Findings:

The Auditor's Office reviewed contacts between the Alliance and City officials during the fourth quarter and identified the following 10 undisclosed lobbying communications:

Violations and Civil Penalty:

The Auditor's Office identified 10 violations responsive to the complaint and considered an additional 15 violations as aggravating factors in assessing a penalty. The Auditor's Office found a total of 25 violations, as follows:

Ten violations for the fourth quarter reporting period of 2020, listed in Table 1:

- Six violations for undisclosed emails requesting funding, action, or access (Items 1, 3, 5, 6, 7, and 8);
- Two violations for text messages requesting funding and action (Items 4 and 10);
- One violation for a letter requesting actions (Item 2); and
- One violation for a phone call requesting action (Item 9).

Fifteen violations for the first through third quarters of 2020, listed in Table 2:

- One violation for undisclosed contract negotiations (Item 14),
- One violation for failing to disclose one City official present at two meetings (Items 7 and 12),
- One violation for a letter requesting action (Item 11), and
- Eleven violations for additional lobbying emails.

<u>City Code 2.12.120</u> allows the Auditor's Office to assess a civil penalty up to \$3,000 per violation depending on the nature and extent of the violation. In assessing a civil penalty in the current review, the Auditor's Office considered the following:

Aggravating Factors:

- The Alliance benefited from undisclosed lobbying efforts, including securing funding for a downtown retail position (related to Table 1, Item 4).
- The Auditor's Office identified a pattern of undisclosed emails with multiple, unreported contacts occurring across quarters.
- Unreported contacts included multiple methods: emails, texts, letters, and calls.
- The Alliance employs at least one former City official who was previously subject to lobbying disclosure regulations, indicating a familiarity with reporting obligations.
- The Alliance is a well-established lobbying entity that has been subject to the regulations for years.

Mitigating Factors:

- The Alliance has not received any warnings for unreported activity since 2014.
- The Alliance experienced a change in leadership since its previous warning.
- On two occasions, the Alliance reported a meeting with City officials in attendance but omitted one City official. We considered these minor violations.

The Auditor's Office set a civil penalty of \$450 for the violations, which is due to the City Auditor's Office by May 10, 2021. Payment must be postmarked by the due date and can be sent by mail to:

Additional Training Recommended:

Current Alliance staff are encouraged to review lobbying regulation requirements and participate in additional training provided by the Auditor's Office. Lobbying regulation resources are available on our Report Lobbying Activities and Lobbyist and Political Consultant Resources webpages. Virtual training sessions may also be coordinated by contacting our office.

Reconsideration and Appeal

Any individual or entity against whom a civil penalty has been issued may request a reconsideration and appeal a decision on reconsideration as provided for in <u>ARA 15.03(H) (Regulation of Lobbying Entities: Enforcement and Civil Penalties).</u>
