A. Sub-Committee Mandate

- The Sub-Committee mandate is a one-page document laying out what the sub-committees do
- Sub committee must create the areas of agreement on access to information

B. Charter 2-10 Sections Related to Access to Information

- Approved by voters on November 2020
- Board must have authority to exercise independent judgment per section 2-1007

C. Council Resolutions 37527 and 37548

- 37527 This resolution doesn't have much guidance to what this subcommittee needs to develop, as it focuses more on how the Commission operates than what the Commission needs to define of how the Oversight Board will operate (including its level of access to information)
- 37548 This resolution defines the Scope of Work of the
 Commission, including its required tasks, and some of those focus on
 Access to Information. These include:
 - Definitions Independent judgment and non-interference
 - Sub-Committee must create an explicit definition of how the new Community Police Oversight Board will function in the area of access to information, including at least subpoena power, access to police records, and compelling testimony

D. Agenda and Scope

- Under the "Establishing Powers and Duties Phase," the

Commission assigned itself the task of determining "how the Board can receive and compel testimony," "Access to records and data within state and federal law, including subpoena power and access to police records."

A. Sub-Committee Timeline

- Roughly four meetings to achieve referring the document to the full commission to review adapt and approve
- The next meetings will be held Dec. 12th and 29th
- B. How this Sub-Committee Relates to other PAC Powers and Duties

 Phase Sub-Committees
 - Both of the other two sub-committees are creating
 proposals for parts of the new oversight system that will
 rely on access of information to be able to function. Those
 other sub-committees will be assuming that this subcommittee will develop a proposal that ensures that level
 of information access.
 - Sub-Committee co-chairs, as well as commissioners who are apart of multiple sub-committees, can cross pollinate information between them
- Round-Robin Discussion: Who would we want to hear from / be briefed by?
 (timestamp 0:30:00)
 - Commissioners suggest being briefed by CRC again to discuss barriers around accessing records
 - Commissioners suggest bringing in someone who works in information and technology in the city, to ensure safe, encrypted and secure information to the new board.
 - Commissioner discuss bringing in legal counsel to discuss the issue

- Commissioner tentatively suggest the office of Community
 Technology
- Commissioners suggest labor attorney who is not associated with the city, as well as IPR
- Commissioners mention that body cameras could potentially fall
 into the scope of work and suggest inviting a body camera expert
- Commissioners suggest getting access to prior records
- Commissioners suggest inviting police association attorney

For the purpose of determining constitutionality, every section, subsection and subdivision thereof of this Section, at any level of subdivision, shall be evaluated separately. If any section, subsection or subdivision at any level is held invalid, the remaining sections, subsections and subdivisions shall not be affected and shall remain in full force and effect. The courts shall sever those sections, subsections and subdivisions necessary to render this Section consistent with the United States Constitution and with the Oregon Constitution. Each section, subsection and subdivision thereof, at any level of subdivision, shall be considered severable, individually or in any combination.

Quarterly mandatory random drug testing not to include cannabis. 3. A creation of an app where citizens can easily file a complaint about an officer. This app would not be for egregious misconduct, but for the every day disrespect intimidation and harassment people encounter when dealing with PPB. 10 complaints and an officer

has to go through de escalation, racial profiling training. If an officer has to do the training more than 3 times, loses their badge. Just like any other business 4. Background checks on all current and incoming PPB. Any association with any hate group refers them unqualified to serve. I could go on, but all of this seems really obvious. What NEEDS TO CHANGE is the unions unilateral ability to protect the most dangerous thugs in Portland.
