

The purpose of the SAFER Grant Program is to provide funding directly to fire departments and volunteer firefighter interest organizations to assist in increasing the number of firefighters to help communities meet industry minimum standards and attain 24-hour staffing to provide adequate protection from fire and fire-related hazards, and to fulfill traditional missions of fire departments. BENEFITS FUNDED

The City of Portland offers a comprehensive benefit package that is competitive with other private and public sector employees. The basic benefits package includes a choice of 2 medical/vision plans and 2 dental plans with coverage available to spouses, domestic partners, and dependent children. The City pays 95% of the cost over coverage and the employee pays 5%. The basic benefits package also includes wellness benefits (discount at fitness clubs, smoking cessation benefits, worksite vaccinations), basic life insurance, long-term and short-term disability, and an employee assistance plan that provides confidential counseling services for employees. The average annual cost to PF&R of providing this benefit package is \$20,704 per firefighter in year 1. Based on recent experience in health premiums, PF&R assumes rates increase 3% annually to \$21,325 in year 2 and \$21,965 in year 3. These averages are based on the current mix of health plans (employee, employee plus 1, and family) chosen by PF&R firefighters. PF&R firefighters belong to the Oregon Public Service Retirement Plan (OPSRP) after 6 months of employment and are vested after 5 years of employment. The OPSRP plan provides a defined benefit at retirement and an investment account based-based benefit. Both are funded through employer contributions to the plan. In total, the City of Portland contributes 31.72% of a firefighter's salary to OPSRP to fund retirement costs after 6 months of employment. The City of Portland also pays 2 payroll taxes on firefighter salaries: the federal Medicare tax at 1.45% and a local transit tax to Trimet (the region's transit agency) of 0.7837%.

As such, it does not apply to tools, equipment, and supplies, such as temporary scaffolding, brought to the construction site and removed at or before the completion of the infrastructure project. Nor does a Buy America preference apply to equipment and furnishings, such as movable chairs, desks, and portable computer equipment, that are used at or within the finished infrastructure project, but are not an integral part of the structure or permanently affixed to the infrastructure project. When necessary, recipients may apply for, and the agency may grant, a waiver from these requirements. (a) When the federal agency has made a determination that one of the following exceptions applies, the awarding official may waive the application of the domestic content procurement preference in any case in which the agency determines that: (1) applying the domestic content procurement preference would be inconsistent with the public interest; (2) the types of iron, steel, manufactured products, or construction materials are not produced in the United States in sufficient and reasonably available quantities or of a satisfactory quality; or (3) the inclusion of iron, steel, manufactured products, or construction materials produced in the United States will increase the cost of the overall project by more than 25 percent. A request to waive the application of the domestic content procurement preference must be in writing. The agency will provide instructions on the format, contents, and supporting materials required for any waiver request. Waiver requests are subject to public comment periods of no less than 15 days and must be reviewed by the OMB Made in America Office. There may be instances where an award qualifies, in whole or in part, for an existing waiver described. For awards by the Federal Emergency Management Agency (FEMA), existing waivers are available and the waiver process is described at 'Buy America' Preference in FEMA Financial Assistance Programs for Infrastructure | FEMA.gov. Article 34 SAFECOM
