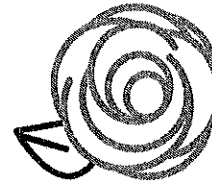

<p>HOW TO FILE THIS FORM – 3 OPTIONS</p>	<p>7 Option 1: Email only the form to SmallDonorElections@portlandoregon.gov and, within 7 calendar days, submit the required attachments via the <u>secure link we will email you</u>. <u>Do not email attachments; they contain financially sensitive information.</u> Option 2: Mail form and attachments to Small Donor Elections, 1120 SW 5th Ave, Suite 901, Portland, OR 97204. Option 3: Drop off form and attachments to 1120 SW 5th Ave during City business hours and tell the front desk it is for the Small Donor Elections program.</p>
