Notice of Bureau of Development Services Open House on Administrative Rule: Tree Replanting Requirements for Tree Removal on Private Property, City-Owned and Managed Sites and Public Rights-of-Way

Why am I receiving this notice?

You are receiving this notice because you participated in or expressed interest in the Citywide Tree Policy Review and Regulatory Improvement Project (Citywide Project) and Title 11, Trees, or you are a member of a neighborhood or business organization.

What is this project about?

On January 2, 2015 a new Title 11, Trees went into effect. This new code contains tree regulations for private property owners seeking to remove trees in their yard as well as regulations for City initiated projects such as street improvements and development on city-owned property. The Proposed Administrative Rule is designed to clarify tree planting requirements. Under the tree code, new trees must be planted when trees are permitted for remvoal. However, in a number of situations, the code does not specify how many trees must be planted. The Proposed Administrative Rule defines tree replacement requirements and builds on existing tree code policy to ensure tree replanting specifications are applied equitabely, consistently and are transparent and predictable. As such, these rules will facilitate effective administration of Title 11, Trees.

An Interim Administrative Rule went into effect on April 20th, 2015 and has been reviewed by multiple City agencies, the Urban Forestry Commission, and the Tree Project Oversight Advisory Committee. Many of these review bodies submitted comments. Some of the comments resulted in proposed changes to the Rule and are indicated by an <u>underline</u> and strikethrough in the document. The remaining comments will be further discussed after the public review.

How can I review this proposal?

Get a copy of the Administrative Rule and City Agency Comments. The proposed Administrative Rule as well as comments submitted by City agencies, the Urban Forestry Commission and Oversight Advisory Committee will be available the week of September 7, 2015. You can pick up a copy at the Bureau of Development Services office at 1900 SW 4th Avenue, 5th Floor reception.
